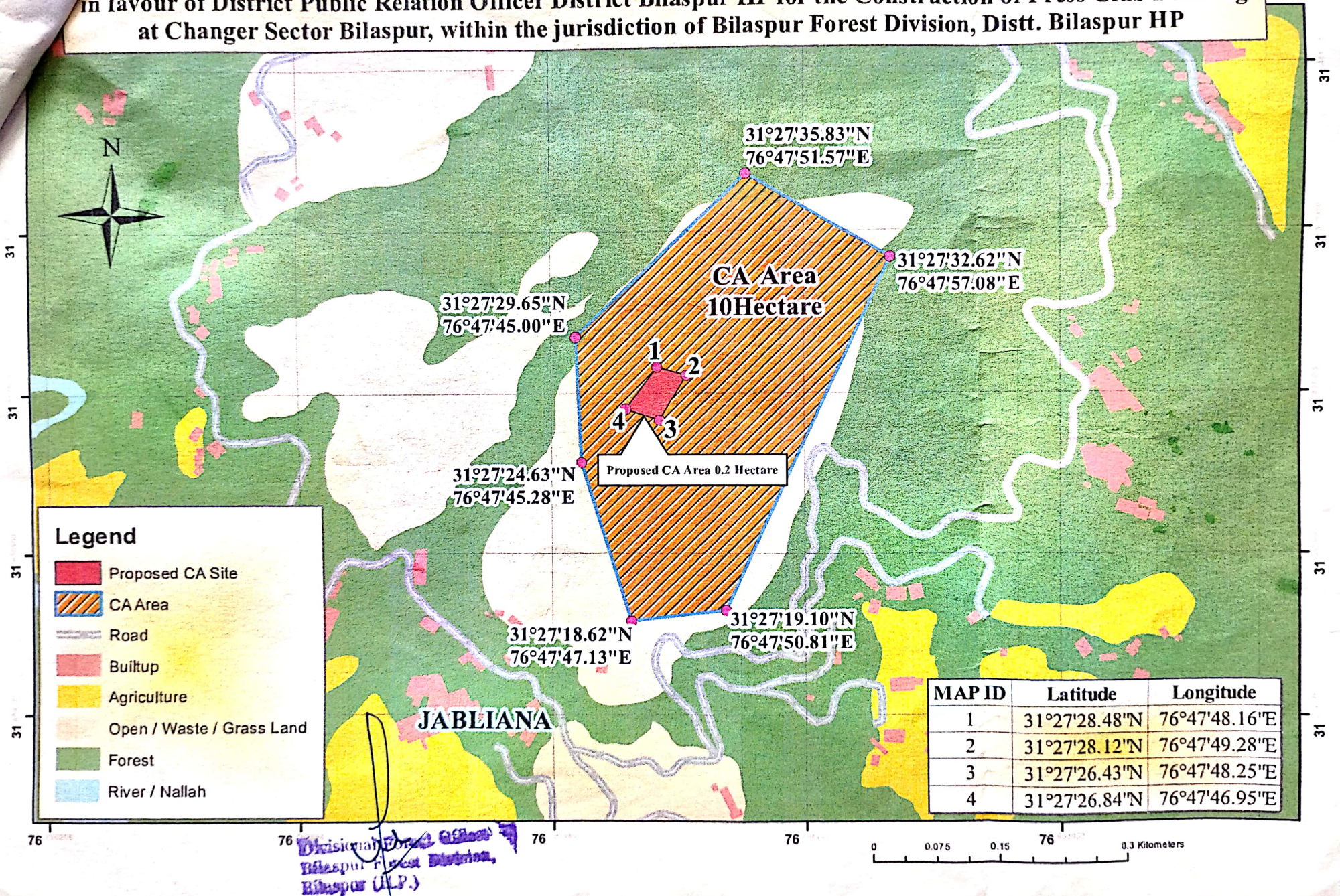

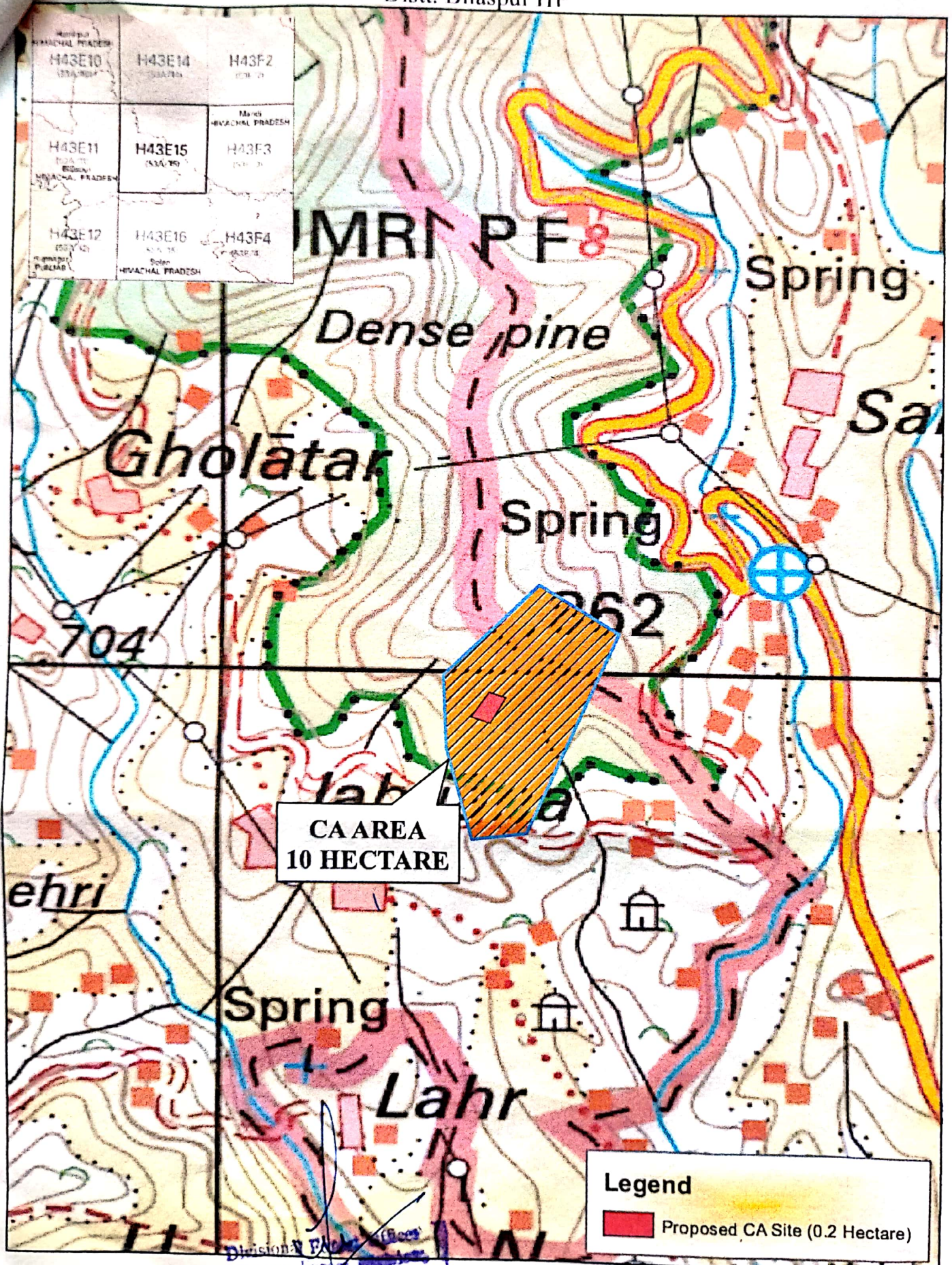

 Distt. Bilaspur HP


