





THIS INDENTURE made the tenth day of July, 1924 (Nineteen hundred and twenty four) BETWEEN the Deputy Commissioner of Naini Tal (on behalf of the Right Honourable Secretary of State for India in Council, hereinafter called the "LESSOR") of the one part AND The Roman Catholic Bishop of Allahabad and his Successors in Office (hereinafter called the "LESSEE") of the other part witnesseth that in consideration of the NOMINAL rent hereby reserved and of the covenants on the part of the Lessee hereinafter contained, the Lessor doth hereby demise unto the Lessee all that plot of land containing by measurement 9.33 (nine and thirty three) acres FORMERLY in Bhowal bhck Compartment Nos. 19, 20 and 25 Naini Tal Forest Division bounded by pillars as per detail in the attached description of the boundary for the sake of greater clearness delineated or shown on the plan hereto attached and thereon coloured.

TO HOLD the same unto the Lessee for the term of ninety (90) years from the first day of July 1924 rendering therefore during the said term a NOMINAL rent of rupees five (Rs. 5/-) payable before or on the 1st July 1924 at the Office of the Deputy Commissioner of Naini Tal.

And the Lessee hereby covenants with the Lessor as follows:

1st: that the Lessee will during the term hereby granted pay unto the Lessor the yearly rent hereby reserved on the day and place hereinbefore appointed.

2nd: that the Lessee will use the said demise premises for the purpose of erecting a Church, Priest House, School, Teachers and servants quarters.

3rd: that the Lessee will be responsible for the action of his men and servants if they do any kind of damage to the surrounding forest. Care must also be taken to protect the water pipes which cross the area. If it is necessary for building purpose to DIVERT them this must be done at the cost of the Lessee. If the pipes are covered over in any way this must be done in such a manner that they can easily be got at whenever repairs become necessary.

4th: that the Lessee will on the expiration of the term of his lease peaceably surrender the said demise to the Lessor; PROVIDED:

a) that the Lessor will on the expiration of the term of this lease if the demised land be NOT otherwise required by the Lessor, GRANT to the Lessee a fresh lease of the said land for a further period of ninety (90) years, and so on.

b) also that upon the expiration of the term of this lease or of any renewed lease, which may be granted as aforesaid, the Lessee shall be allowed such period as to the Lessee may seem sufficient, NOT being less than twelve months, within which to remove any buildings which he may have erected or any materials which he may have brought upon the demised premises, BUT upon failure to remove the said building or materials within the time so limited the same shall become the property of the Lessor.

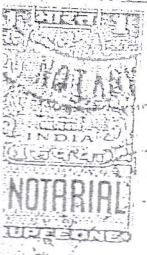


POWER OF ATTORNEY

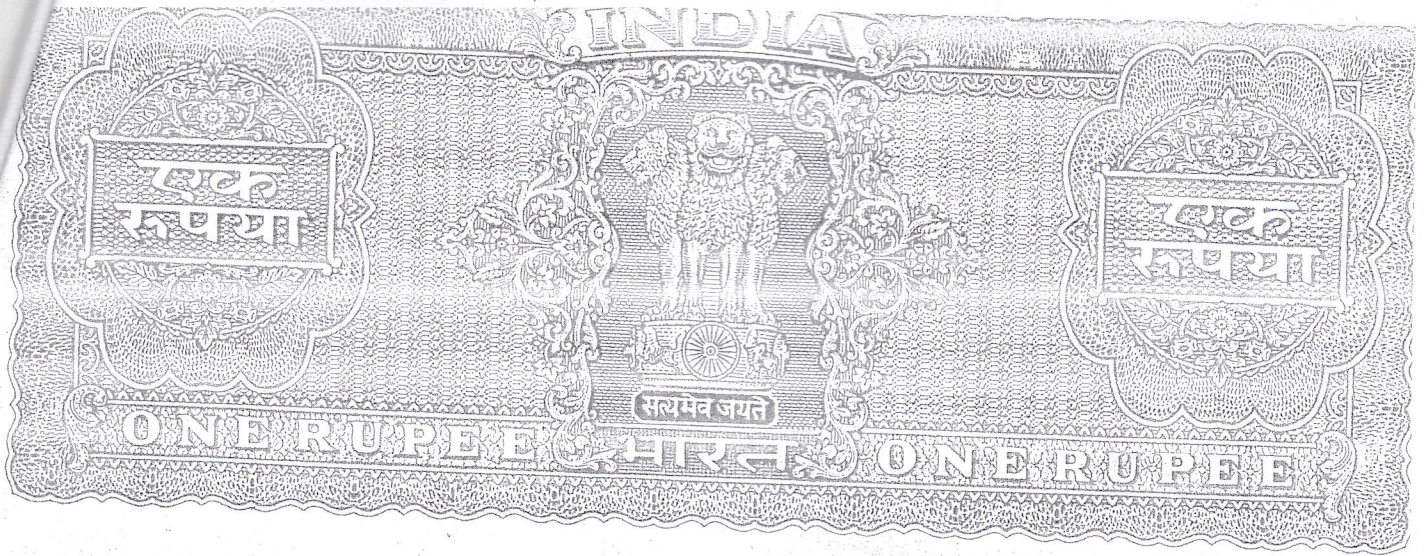
THIS POWER OF ATTORNEY is executed on this the *fifth* day of August 1987 by me the Rt. Rev. B. Mudartha, Bishop of the Roman Catholic Diocese of Allahabad, residing at Bishop's House, Allahabad (hereinafter called the Director General) 32, Thornhill Road, Allahabad - 211002.

WHEREAS the Director General is the lessee in possession of the property known as "Rosary Villa" situated in Bhowali, District Nainital, by virtue of and under the indenture of lease made on the 10th day of July 1924 between the then Deputy Commissioner of Nainital and the Roman Catholic Bishop of Allahabad and his Successors in office whereby plot of land containing by measurement 9.33 (nine point thirty three) acres, then in Bhowali Block Compartment nos. 19, 20 and 25 Nainital Forest Division, was demised to the Roman Catholic Bishop

of Allahabad for a period of 90 years from the First of July 1924 for the purpose of erecting a Church, Priest House, School, Teachers' and Servants Quarters

AND WHEREAS the Roman Catholic Bishop of Allahabad got constructed Buildings as aforesaid on the said plot of land which are now collectively known as "Rosary Villa".

AND WHEREAS the Director General being far away from the aforesaid premises is unable to look after the proper management, upkeep and preservation of the said premises.

AND WHEREAS the Rev. Sisters of the Ursulines of Mary Immaculate (U.M.I.) of Cannanore, a Society duly registered under the Societies Registration Act XXI of 1860 having its registered office at Ursuline Convent, Payambalam, Cannanore in the state of Kerala (hereinafter called the said Society). The President Rev. Maria Alberoni of the aforesaid Society has agreed to look after the management, upkeep and preservation of the said premises for and on behalf of the Director General.

AND WHEREAS the Director General has decided to appoint the said attorney President Rev. Sr. Maria Alberoni

NOW THEREFORE this power of Attorney witnesseth as under:-

1. That I, the said Director General, do hereby appoint and constitute the said President of the Society Rev. Sr. Maria Alberoni as my Attorney to exercise any of the under mentioned powers hereby conferred, in my name and for my use:-

a) To take possession of the aforesaid premises known as Rosary Villa^W, its lands and tenements^W as I am now or in any way be entitled to and to bring any proceeding or action in respect to or for or concerning the said premises, lands or tenements^W and also to demand, receive, recover and give receipts for the rents and damages thereof respectively for my use;

b) To sign in my name and as my act and deed, to execute, verify and deliver any plaint, written statement, contained agreement relating to or concerning the said premises or any part thereof;

To commence, carry on or defend all actions and other legal proceedings concerning the said premises or any part thereof or concerning anything in which I may be a party;

- d) To manage, preserve and keep in proper repairs the said premises and every part thereof and make due compliance with the terms and conditions of the afore said lease dated 10th July 1924 relating to the said premises;
- e) To use the said premises strictly in accordance with the terms and conditions laid down in the aforesaid Lease dated 10th July 1924, a true copy whereof is annexed to this power of Attorney;
- f) To appoint and remove in its absolute discretion any substitute for or agent under my said Attorney in respect of all or any of the matters aforesaid upon such terms as it may think fit;
- g) and generally to do, execute and perform all and every other act, matter and thing whatsoever in any way necessary or expedient, to be done in regard to the said premises as fully and effectually as if I were personally present to do the same;

AND I the said Rt. Reverend B. Mudartha, son of late Mr. Joseph Mudartha, Bishop Roman Catholic Diocese of Allahabad for myself and my successor in office hereby agreed to confirm and ratify all and whatsoever the said Attorney or any substitute or agent appointed by

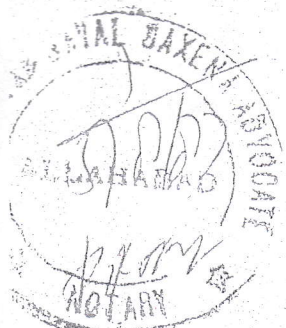
