Memo: DFO Palampur has sent the proposal for diversion of 2.01.39 ha of forest land for the construction of Dheera Balota Small Hydro Electric Power Project (5.00 MW) by Director National Career Public Education Society Dheera Balota Small Hydro Project Distt. Kangra, HP under the provisions of Forest Conservation Act, 1980. The detail of the forest land to be diverted for non-forestry purpose is as under:-

2. The User Agency has agreed to pay for the raising of Plantation under Compensatory Afforestation over 4.02.78 ha in CFS Gaggal amounting to Rs. 6.02.800/- . The User Agency has also agreed to pay the Net Present Value etc. under the provision of Forest (Conservation) Act 1980. The documents pertaining to the proposal as per check list & site inspection report of undersigned are enclosed in proposal folders.

It is therefore, requested that the necessary approval for the diversion of 2.01.039 ha of forest land as mentioned above for the construction of Dheera Balota Small Hydro Electric Power Project (5.00 MW) to Director National Career Public Education Society Dheera Balota Small Hydro Project Distt. Kangra, HP may kindly be obtained from Govt. of India under Forest (Conservation) Act 1980 and conveyed to this office at the earliest please.
