

1	State govt. is requested to submit the point wise reply on each conditions of NBWL.	UA has submitted point wise reply and undertakings for each conditions of NBWL and it is also uploaded in additional information part-I.
2	NBWL vide condition no. (i) directed that road width will be 5 meter but the proposal submitted for 7 meter width in reserve forest and 9 meter in civil soyam land and non forest land. state govt. may submit the revised proposal as per NBWL direction.	As per NBWL condition no (i) which directed that width of road is to be kept 5 m in forest area (reserve and civil soyam) and for this latest land schedule is prepared and recounting is done within 5m in forest area thus the total forest area has been reduced. document are uploaded as additional information part-I.
3	NBWL vide condition no (ix), directed for animal passage plan but no details found in the proposal.	NBWL vide condition no. (ix), directed for animal passage plan has been prepared and duly signed by committee formed by CWLW and uploaded in additional information part I.
4	NBWL vide condition no. (xi). directed CWLW to set up monitoring committee but no details found in the proposal.	Monitoring committee has been set up by CWLW as per NBWL condition. Documents in this regard is uploaded in additional information part I.
5	AS per DSS analysis. 4.90 ha. CA area of this proposal is overlapping with some other proposal no. FP/UK/ROAD/20366/2016. In addition. 3 ha. area also round in MDF. State govt. may do the needful in this regard.	New CA area for 9.404 ha has been taken form DFO chakrata, rikhnad range comp no kudog 22 which now required CA area after correcting land schedule (width 5m). Dcouments in this regard is uploaded in additional information part II.

6	Density of the CA area proposed in reserve forest area is mentioned as 0.4 in the CA site suitability certificate. However, as per Guide lines the density/should be less than 0.4 State govt. may submit clarification in this regard.	New CA area for 9.404 ha has been taken from DFO chakarata, rikhnad range comp no. kudog 22 thus new CA site suitability certificate has been uploaded in additional information part II replacing previous CA site suitability.
7	As per NPV calculation sheet. ten times NPV proposed for entire 7.465 ha area. State govt. may verify whether the complete area falls in National Park.	Reply submitted by DFO is uploaded as additional information part II and new NPV certificate is uploaded in additional information part I.
