The Government of India, Ministry of Environment, Forests & Climate Change, New Dehli vide Ref (1) have sought certain additional information/clarification for further consideration of the abovementioned proposal. The same was communicated by Government of Karnataka vide Ref (2) to this office and further by this office vide Ref (3) to the field officers for seeking the required information.

In response, the Deputy Conservator of Forests, Ballari Division and the Chief Conservator of Forests, Ballari Circle vide Ref (4) and (5) respectively have submitted the information/clarification on the points raised by Government of India. Based on the said reports, the reply to the Government of India EDS query is submitted as follows.

The State Government has proposed a compensatory afforestation area of 4.85 ha non-forest land. The DSS report reveals that the proposed CA area is falling inside Bhimgad Wildlife Sanctuary.	Order No. FEE 88 FLL 2016 dated
The Deputy Conservator of Forests, Ballari Division has reported that the violation has taken place, the approach road is already used by the previous lessee i.e. M/s Lakshminarayana Mining Company without forest clearance from 21-05-1983 to July 2011 (i.e. date of first grant of lease). In this regard the Government of Karnataka shall submit a self-contained note along with actions initiated in the matter.	 The proposed approach road was already being used by the erstwhile lessee (M/s Lakshminarayan Mining Company) without obtaining the FC for the road. Subsequently, the said mining lease was categorised as C-category mine as per the report submitted by the Central Empowered Committee to the Hon'ble Supreme Court, based on the illegalities committed by the said lease was cancelled by the Hon'ble Supreme Court and was later eauctioned by the Department of Mines and Geology. Further, the Forest Department had booked Forest Offence Case (FOC) No.08/2014-15 dated 13-10-2014 against the erstwhile lessee for having encroached upon the forest land to an extent of 47.21 ha outside the mining lease area. Later on, the Charge Sheet has also been filed by the Forest Department

	 against the erstwhile lessee before the Hon'ble JMFC, Sandur, vide CC.No.206/2020. The case is presently pending in the Hon'ble Court.
Information regarding whether the approach road is in use presently or not. If yes, who are the beneficiary.	 The proposed approach road is also being used by M/s Chougule and Company (ML No.2546). Further, the new lessee M/s MSPL Limited, Hospet (ML.No.0010) in the instant proposal has already obtained Temporary Permission for usage of the existing Approach Road (in question) vide Government of Karnataka letter dated 25-02-2020 (copy enclosed). A sketch showing the existing Approach Road from ML boundary of Chowgule and Company Private Limited (ML No.2546) to SH-49 passing through Kardikolla Iron Ore Mine of M/s MSPL Limited (ML No.0010) in NEB Range fores Sandur North Range, Sandur Taluk Ballari District is enclosed.

In view of the above, it is requested to submit the above information/ document to Government of India for taking further action.

The present status (Timeline) of the proposal obtained from the FC web portal is also appended for information.
