The proposal was submitted for diversion of 2.469 ha. of forest land in Hattikeri village Sy.No. 10/A1A1A Belekeri Hobali, Ankola Taluk, Uttar Kannada District, Karwar Division for establishing Toll Plaza with amenities. In this regard the Govt. of India has sought some clarification vide cited reference (1) that, KML file of the CA area furnished by the State Forest Department does not includes the KML file of CA raised in non forest area to an extent of 55.00ha. in Shivamogga District and also verified compliance report of 2259.00 ha. forest land submitted by Seabird Project, Karwar.

Accordingly, it is submitted that, earlier reported that, Compensatory Afforestation has been raised over an area 426.20 ha. of forest land in Shimogga, Yellpur, Honnavar, Sirsi and Karwar division and 55.50 ha. of non forest land in Shimogga division in lieu of 2259.00 ha. of forest land diverted to Seabird Project, Karwar. (Out of which 200.00 ha. forest land permitted for non forestry activities).

After reconciliation the Compensatory Afforestation has been raised over an area of 479.85 ha. forest land in Shimogga, Yellpur, Honnavar, Sirsi and Karwar division. The detailed is as under.
