Vide reference 7th cited, the Integrated Regional Office, GoI, MoEF&CC, Hyderabad has informed that the ministry's vide letter dated 18.07.2022 has issued instructions regarding deciding on the applicability of FC Rules, 2022 to the proposals already under process. As per the instructions, the proposals received from the State Government on Parivesh portal have been examined and as the subject proposal was accepted by the Nodal Officer after 28.06.2022 online returned the proposals to process as per the provisions of Forest (Conservation) Rules, 2022. Accordingly instructions issued, vide reference 8th cited, to the UA to upload the proposal in parivesh 2.0.

As the matter stood thus, vide ref 9th cited, the GoI, MoEF & CC, New Delhi has issued guideline on processing of the proposals. As per the clarification given at point

no.3(i) where it is mentioned that the "Proposals submitted in PARIVESH 1.0 after 28.06.2022 and not migrated to PARIVESH 2.0, may be processed using the FC module of PARIVESH 1.0. However to adhere the procedures laid down in the Forest (Conservation) Rules, 2022, the minutes of the meeting of Project Steering Committee (PSC) may be attached with part-IV of forms and passing of proposals of less than 5.00 ha through Conservator of Forests, may be treated inert for procedural/technical purposes." Further, at point no.3(ii) it has been mentioned that "Till a time, the stabilization issues in PARIVESH 2.0 are resolved, new proposals may be submitted in PARIVESH 1.0 and their processing may be done as per arrangement mentioned under para 3 (i) above".

In this particular case, the proposal has already been submitted to IRO in Parviesh1.0 and as per the para 3 (i), proposal can be processed now.

In view of the above, the Regional Officer, IRO, Hyderabad is requested to process the proposal as per the guidelines issued on 14.11.2022.
