With regard to above, the proposal is submitted by this office vide Ref (1) to the Government of Karnataka and by the State Government vide Ref (2) letter dated 25-06-2021 to the Central Government seeking prior approval of Central Government under Section-2(ii) of the Forest (Conservation) Act, 1980. In this regard, the matter was discussed in the Forest Advisory Committee (FAC) in the meeting held on 17.10.2022 and accordingly the Government of India, Ministry of Environment, Forest & Climate Change

(Forest Conservation Division) vide Ref (4) has raised an EDS query to the Government of Karnataka. The Government of Karnataka vide letter dated 07-12-2022 has forwarded the same to this office. The same was communicated to the field officers vide this office letter dated 22-11-2022.

In response, the reply to the query raised by the Government of India is furnished by the Deputy Conservator of Forests, Ballari Division and the Chief Conservator of Forests, Ballari Circle vide Ref (5), (6) and (7) to this office as below.

The Said issue of FRA claims has been raised with respect to proposed Tailing dam-II area of 22.25 hectare. However, M/s NMDC has dropped the proposed Tailing dam-II (22.25 ha) from the original proposal of 75.92 ha. Moreover, FOC has been booked vide FOC No. 12/2020-21 dated 14-7-2022 and 08/2022-23 dated 15-12-2022 w.r.t encroached area of around 1.83 ha. (which is part of dropped area. of 22.25 ha) and it is reported that this encroachment will be evicted subsequently.

In view of the above, it is requested to move the matter with the Government of India, Ministry of Environment, Forests & Climate Change, New Delhi for further consideration of the proposal for according the In-principle Stage-I approval.

Submission of Reply to EDS Subt

With reference to above mentioned subject matter, our FC proposal for diversion of 75.92 Ha Forest land for construction of new Screening Plant-II at Dominalai has been considered and discussed in the FAC meeting held on 17.10.2022. In the said FAC, our proposal has been deferred for want of below mentioned information from the State Government,

- The State Government shall submit the justification for creation of two tailing dams in the forest land in view of the observation made by IRO, Bangalore,
- The State Government shall clarify regarding rights claimed under FRA, 2006 as per the submission made by the letter dated 13.10,2022 vis-à-vis certificate dated 13:09,2019 submitted by the DC. Ballari earlier with the instant proposal.

In this regard, we would like to submit the following reply based on observation of IRO, MoEF&CC, Bangalore.

Reply to point No. 1

The proposal involves diversion of 75.92 Ha Forest land which involves 12.96 Ha for construction of screening plant-II, 40.25 Ha for Tailing dam-I, 22.25 Ha for Tailing dam-II and 6.46 Ha for water & storry pipeline. At the proposed Screening cum Beneficiation Plants II, the iron rue tailings will be generated from beneficiation plant. The processed water after washing of iron ore in plant contains concentration of suspended solids and is called as iron ore tailings tslimes). The equipment such as Classifiers, de-sliming cyclones, densitying cyclones, horizontal belt filters and thickeners have been considered in the beneficiation circuit of proposed plant to recover non one lines and also water to the maximum extent,

As per process, for feed rate of 1800 IPH, only 2.38% of slimes will be generated which contains 43:01% of Le. The quantity of tailings expected to be generated is 0.1666 MIPA during Phasest (7 MTPA) and 0.238 MTPA in Phase II (10 MTPA). Considering the density

of tailings as 2.4 t/m³, 69417 m3 during Phase I; during Phase II, 99,167 m³ of tailings will be generated annually.

The tailings will be disposed-off in proposed 2 no's of tailing pond(s) located nearby Screening Plant-II. "The tailings will be pumped to the tailings pond(s) through two pipelines, one of 200 m length, the other 1110 m long. The pumping arrangements will be made at Tailing Pond in such a way that slime will be discharged at one end and clear water available at other end will be pumped back to the re-circulation water tank for re-use.

Tailing Pond-I (capacity ~2.386 Mm³, 40.25 Ha) can meet the requirement for 24 years and Tailing Pond-II (capacity~1.162Mm³, 22.25 Ha area) for next 13 years.

It was proposed to construct Tailing dam-I & II in a phase wise manner. However, NMDC has submitted Forest clearance proposal for obtaining diversion of forest land in one go for complete area i.e 75.92 Ha which involves areas of both Tailing dams and Screening Plant-II area and slurry pipeline etc.

In view of the observation of FAC, NMDC propose to construct Tailing dam-I (40.25Ha) area which will meet the requirement for 24 years. Hence, the effective diversion area will be 53.67Ha (12.96Ha for SP-II+40.25Ha for Tailing dam+0.46Ha for slurry/water pipeline).

Reply to observation of IRO, MoEF&CC, Bangalore:

Justification on availability of water:

NMDC has obtained approval of water allotment of 13.45 Cusecs (32,910 KLD) from Narihalla dam constructed near Taranagar, Sandur Tehsil, Ballari District from Water Resource Dept, Government of Karnataka. NMDC has made necessary pumping arrangements for drawl of water for use in Donimalai Iron Ore Mine (DIOM) and Kumaraswamy Iron Ore Mine (KIOM). There is adequate quantity of water available for mining, plant operations including screening plant and domestic use for NMDC mines i.e. DIOM & KIOM.

Justification for not putting existing Tailing dam at Donimalai to use for proposed Screening Plant-II:

NMDC has constructed one tailing dam at Donimalai in the year 1968 for impoundment of slimes generated due to wet Screening operations at Screening Plant-I of Donimalai iron ore mine. The capacity of tailing dam is 13 million tons capacity at RL 672mRL. The total area of dam is 43.69 Ha. Further, NMDC has established 1.2 MTPA capacity Iron Ore Beneficiation Cum Pellet plant at Donimalai. The slimes accumulated in the existing Tailing Dam over a period of time is a raw material for Iron Ore Beneficiation plant. The lean tailings generated from the Beneficiation Plant shall be impounded in the same Tailing dam by construction of dykes so that the same shall not be intermixed with slime material already existing in the Tailing dam.

At present, the Tailing dam is at its full capacity and hence, the existing screening plant-I is operated on dry mode which is otherwise not due to shortage of water. The existing Tailing dam caters to the requirement of Donimalai Iron Ore Mine.

Hence, the existing Tailing dam at Donimalal cannot be connected to proposed Screening Plant-II. For this reason, only, the separate Tailing dam is proposed for entering to the requirement of proposed Screening plant-II.
