1.	<p>In reference to the observation No. 1 administrative and financial approval of the instant proposal was sought from State Govt. In reference to this. State Govt. has submitted the Admin approval; however it is not clear whether the instant proposal is part/extension of other proposal or this itself a separate proposal. The State Govt. needs to clarify the same and also provide a copy of the same showing the name and RD wise length of the proposed alignment duly authenticated by competent authority.</p>	<p>In this connection user agency has intimated that the instant proposal is an independent and standalone proposal and does not form part of, nor is it an extension of any other proposal (i.e itself separate proposal) submitted earlier or presently under consideration. It is submitted that as per the Budget Book, the required budget for the construction of the link road from Gulriya Dhang to Nero Kotli (Km 0/0 to 4/935) has been duly provided by the Financial Department, Govt of Himachal Pradesh, under the Budget for the financial year 2023-24 (Copy of the same has been uploaded in addition information details against Sr. No. 26 of Part-I), which was presented before the Himachal Pradesh Legislative Assembly on 17th March, 2023.</p> <p>The Administrative Approval & Expenditure Sanction (AA & ES) for the proposed road is presently under process at the competent authority level. Due to the prescribed procedural requirements, some time is required for its final issuance. User agency has submitted that approved A/A & ES shall be furnished prior to Stage-II approval, alongwith with the compliance report, as per the applicable guidelines.</p> <p>User Agency has requested that in view of confirmed budget provision by the Financial Department, Govt. of Himachal Pradesh this proposal may be considered and Stage -I (in-principle) approval may kindly be granted to</p>
