In inviting a reference to the above cited correspondence on the captioned subject, it is to inform you that the DFO, City Forest Division has furnished the point-wise compliance of the discrepancies observed by Dy. Inspector General of Forests (C), GoI, MoEF & CC, Regional Office, Bhubaneswar vide Letter No. 5-ORC635/2024-BHU dt. 29.02.2024 on the matter of diversion of 32.717 ha. Revenue Forest land in Mouza Harapur, Harekrushnapur, Durgapur and Alkar under Jatani Tahasil in Khordha District for Establishment of Infovally Electronics Manufacturing cluster to this office during the course of scrutiny of Diversion Proposal.


The point-wise compliance of the discrepancies observed submitted by DFO are furnished as follows :-

b)	The State Govt. has not furnished the trees enumeration list in respect of non-forest land involves in the project.	There is no tree over non-forest land involved in Infovalley project as reported in this office Memo. 60 dt. 03.01.2024. (Annexure -II)
c)	The concerned DFO has not uploaded the KML files, Sol Topo sheet, DGPS map of proposed CA/ Addl. CA areas and CA/ Addl. CA schemes in Parivesh web portal.	The concerned DFO has uploaded the KML files, Sol Topo sheet, DGPS map of proposed CA/ Addl. CA areas and CA/ Addl. CA schemes in Parivesh web portal by the User Agency.
d)	The user agency has not submitted the KML/ Shape file of non-forest land/ degraded forest land identified for CA/ Addl. CA and entire project area with the proposal.	The user agency has submitted the KML/ Shape file of non-forest land/ degraded forest land identified for CA/ Addl. CA which has been uploaded in the portal.
