Sub:- Diversion of 0.121 ha Reserved Forest in favour of M/s Dosti Agro Tourism Centre, Pune for laying water pipeline, erection of electric pole to supply electricity aerial iron cable for cable car and regularize existing approach stairs pathway for Dosti Agro Tourism Centre in Village- Karanjale, Taluka- Junnar, District – Pune in the State of Maharashtra- regarding.

The subject cited in above reference includes the detail information regarding the proposal for diversion of 0.121 ha. Reserved forest land for water pipeline, erection of electric pole to supply electricity, Aerial iron cable for cable car and regularize existing approach stairs pathway at-village-Karanjale Tal-Junnar, Dist-Pune. The proposed water pipeline, erection of electric pole to supply electricity, Aerial iron cable for cable car and regularize existing approach stairs pathway is passing through forest Comptt.No.64 Gat No.120 of village-Karanjale Tal-Junnar, Dist-Pune. As per the above reference No.2 & 3 the raised queries of our level has been complied as below table.;

Sr.No	Raised Queries	Compliance of queries.
I	Discrepancy is observed in the area calculation statement submitted by the State Government, KML file and statement made by the User agency in the Proposal. In area calculation statement, forest land is proposed for laying water pipeline, erection of electric pole to supply electricity, aerial iron cable for cable car and regularize existing approach stairs pathway, whereas, KML is submitted for road and ropeway. Further, User Agency has mentioned in their Part-I that nearby villagers use stairs instead of the road.	The KML file regarding road and ropeway has been wrongly submitted by mistake. In the case KML file regarding of the laying of water pipeline, erection of electric pole to supply electricity, aerial iron cable for cable car and regularize existing approach stairs pathway is being submitted in three CD copy with google maps 6 sets each proposed works attached herewith.

	Clarification regarding why road is proposed when User Agency is requesting.	In view of query raised regarding the road, it is stated that the road has not been mentioned & proposed in the part-II and site inspection report submitted by us. It is requested that, please verify part II and site inspection report.
	to regularize existing approach stairs pathway needs to be submitted along with revised KML file high lightning various component.	As per above revised KML file high lightning various components submitted herewith.
II	DCF has stated in his Part-II that the area proposed for diversion is vulnerable for erosion. Accordingly, soil conservation measures is not proposed. Soil conservation measures to avoid erosion may be submitted.	As the proposed land is very hilly and it includes high precipice peak. Hence, it is not practically possible to carry out soil conservation measures there.
III	Further, DCF has mentioned in his Part- II that surrounding area falls under Western Ghats and definitely has unique flora and fauna. List of unique flora and fauna found in the surrounding area along with conservation measures if any needs to be submitted.	List of unique flora and fauna found in the surrounding area attached herewith in 6 copies.
IV	Signed copy of Specific recommendation of PCCF (HoFF) is not submitted along with the proposal. Signed copy shall be submitted.	This subject pertain to PCCF (HoFF) Office level.
V	The detail report on violation of FCA, 1980 including nature and extent of violation, name of official persons responsible for violation and action taken there of need to be submitted.	The detailed report on violation of FCA, 1980 and persons responsible for it, is attached herewith in 6 copies..
VI	Three alternatives has been explored, however, KML file of the same is not submitted along with the proposal.	Three alternatives has been explored, KML file of the same is submitted along with this letter again as per above Sr.No.-I
VII	Details of employment potential in terms of man days of skilled, semiskilled and unskilled persons on permanent (direct and indirect) and temporary (direct and indirect) basis have not been provided. The same needs to be provided.	As per the project agency report the details of employment potential in terms of man days is as under; 1.Skilled 5% = 188, Temporary basis. 2.Semiskilled 15% = 566 Temporary basis.

As per above table the raised queries of project agency level and this office level have been fulfilled. Hence the proposal for diversion of forest land of Village-Karanjale, Tal-Junnar, Dist- Pune in four copies with KML files under Section 2 of the Forest (Conservation) Act, 1980 is recommended for further approval.
