Sl. No.	Observations	Reply
1	The State Government has not provided the details required to be submitted along with fresh mining proposals as per Para 7.8 (i) of FC guidelines.	In this regard user agency has submitted Geological report and quarrying plan from Recognized Qualified Person (RQP), the same has been enclosed herewith.
2	Reason for carrying out the non-forestry activity in the proposed forest land without obtaining FC as per Forest (Conservation) Act, 1980.	The temporary quarry operated by temporary quarrying permission about last 25 years. The reason for proposed forest land operated for non forestry activities without obtaining FC Act, 1980 can't be explained at this stage.
