As desired by Government of India vide their letter dated 12/09/2018 under reference, Chief Conservator of Forests (T), Thane has submitted the required information vide their letter dated 22/10/2018, Clarification on points raised by Government of India are submitted as under :-

Sr. No.	Point raised by GOI	Compliance
i	A map on appropriate scale duly showing the land for which approach is solicited.	The user agency has submitted the map on appropriate scale is enclosed as <b><u>Annexure-1</u></b>
ii	What is the extent of the land for which approach is needed ?	The project authority has submitted that the proposed approach road is required for their private land admeasuring of 7.19 ha.
iii	What is the land use of the land presently and what are the future plans for its land use.	The Project authority mentioned that at this stage no development plan is proposed. Only after obtaining permission for approach road from Govt of India, land use will be decided by getting necessary permission from District Collector/Town Planning Department & local planning authorities.

		<p>At present the area comes under the Naina, CIDCO, Navi Mumbai and layout plan is pending for approval.</p> <p>The said area as per the draft approval layout plan is yet to be decided. - <b>Annexure 2</b></p>
iv	Is this land is and isolated patch in the forest or a part of the habitation	Deputy Conservator of Forests , Alibag certified that the Private land is not isolated patch in forest or a part of the habitation.
v	How presently vehicles are coming to this site	Project authority submitted that "There is no authorized existing road is available to access of our private land, hence forest land is required for approach road". The Project authority use the proposed forest area for approach to their private property without construction of any road or breaking of forest land.
vi	What are the plans of District administration to attach it to the main Road?	Project authority submitted that "If permission is granted, the proposed road will be attached to existing Z. P. (Village) road. The same is connected to State Highway No. 81. The proposed plan of District Administration is not known.

It is therefore requested that the Government of India may kindly be moved to approve diversion of 0.1911 ha Reserved Forest Land for construction of approach road , laying of underground Electric Cable and 6" dia G.I. Water pipe in view of the common and basic amenities to access the land of Shri Pandurang Parshuram kharpatil , Survey No 195/0 in Raigad district under section 2 (ii) of the Forest (Conservation) Act, 1980.
