2 The pointwise reply of the observations as raised vide your above referred letter is submitted as below:-

1. Necessary correction has been made at Para (i) a, b & C online Part-II.
2. The detailed clarification for not identified private land for dumping the muck generated duly authenticated by DFO concerned has been enclosed herewith.
3. The information at Para E (ii) online Part-I has now been corrected.
4. The revised geo-referenced map and KML file of CA area has been uploaded in online Part-II and the copy of same is enclosed herewith.
5. The comments of CWLW are under process.
6. The Kutcha road as seen at both ends in KML file has already been constructed on private land.
7. In reply to this point the villagers to be connected through this road have no connectivity since independence. The only lifeline to these villages is a Narrow Gage railway line passing nearby, which also stops during the monsoon. The construction of this road shall shorten the distance to the railway station Lunsu on Panthankot Jogindernagar Railway line and provide access to both the roads thus providing all time wheather road to the villagers and people travelling through trains.
