बिन्दु स० 1	It is seen from DSS analysis of the revised KML file of the proposed ca area that 1.00 ha area out of 4.312 ha area falls in Moderately Dense forest (MDF) which is not considered suitable for ca state govt may change 1.00 ha area falling in MDF and submit/upload GIS software generated geo referenced digital map map in sol toposheet and suitability certificate etc.	Revised KML file proposed for CA area 4.312 ha has been prepared & uploaded in part-1.
बिन्दु स० 2	It is seen from the village wise breakup of forest land given in pera-B-2.3 of online part-1 that the forest land falling within the jurisdiction of sasola village and hatrasia village is involved in the construction of proposed road. On the other hand. Dc has mentioned in the FRA certificate that the forest land proposed for diversion falls within the jurisdiction of basdeo, sasola & Hatrasia villages. Further the proceedings of sasola & kandekanyal villages only have been submitted under FRA state govt. may clarify the confusion in the name villages mentioned above and submit proceedings of the village level committee meetings of all the villages under FRA	A complet FRA certificate has been made and uploaded in part-1 for villages, Basudeo Sasola Hathrasiya & Bhakarpanth.

बिन्दु स० 3	It is mentioned in the muck dumping plan that 1960 cum of surplus muck is proposed to be dumped at two muck dumping sites located in the van panchayat. Land and civil land of stae Govt. but this land has not been included in the forest land proposed for diversion. State Govt may include the land required for the muck dumping in the forest land proposed for diversion and submit revised document.	In the proposal 6 sites located for muck disposal & not included in the forest land proposed for diversion. Because the road is proposed for village & 9 mtr width is taken in land schedule the road will be constructed approx. within the width of 6 mtr the muck will be disposed within 3 mtr width after construction of RR Dry wall which land is included in land schedule.
4	State Govt. may submit original copy of the geo referenced digital map of the proposed road as well as land proposed for CA for placing in the hard copy of the proposal.
