extended from 3.66 m. width to 9.00 m width. Hence, the balance width of 5.34 m is required to be laid. Hence, clearance under Forest Conservation Act, 1980 is required. Copy of the notification is enclosed.

The proposed road is covered in Survey of India topo sheet no.65 G/15 and 65 G/14. Copy enclosed.

 In the notification it is shown as Tandapalli PF (excluring Velamalakota RF). However, it is Tadepalli PF, but not Tandapalli PF.

The District Forest Officer, Kakinada reported that Tandapalli (Tadepalli) protected forest was notified U/s -24 of AP forest Act,1967 (Act-I of 1957) in G.O. MS. no. 656 Forest and Rural Development (Forest.III), Dt. 08.09.1975 and published in A.P. Gazette dt. 30.10.1975.

In the notification the boundary description for south of the Tandapalli (Tadepalli ) PF reads as follows;

"Thence the boundary runs along the foot path to Siripuram and thense to Medicherla viz., Vadapalli, Gunjugudem and Immidivaram. Thence along the foot path from Madicherla to a point where it meet Velamalakota RF and thence to Denduluru, Nurupudi to a point where it meets Maredumilli south Extension-I RF along the existing foot path".

The proposed road for an extent of 3.99 ha (7.471km length and 5.34 m width) is covered by foot path to Siripuram and thence to Medicherla viz., Vadapalli, Gunjugudem and Immidivaram.

The proposed road is covered in Survey of India topo sheet no.65 G/15 and 65 G/14. Copy of the notification and map is enclosed herewith.

Further, it is submitted that, the road passes through the following villages viz., Immidivaram, Gunjugudem, Vadapalli and Narasapuram villages. As per the village maps /FMB (Field Measurement Book) furnished, the following are the details of year of the villages maps. Copy of the village maps are enclosed herewith.
