**Compliance:** In compliance to the observation, the project proponent vide his letter no.5349, dt.26.09.2025 addressed to Divisional Forest Officer, Baripada Division has submitted details of activities undertaken and extent of forest area used therein for non-forestry purpose. A copy of the report of Project Proponent is enclosed herewith for compliance.

**Observation No.02:** KML file of the new CA land has not been furnished. As a result, DSS analysis and documents/information for further course of action.
