Further, the comments on RoW has not been given and it may be informed whether the trees coming under the RoW has been added in the proposal or otherwise.	The Component wise area has been mentioned separately in part- I para B 2.4. Accordingly, revised copy of Checklist No. 7 and 32 have been uploaded in Part I at Sr. No. 38 and 39 respectively. Further the RoW for underground T/line is 0.600 mts and relevant document of T/line and road have been uploaded in Part- I at Sr. No. 23. Since the T/line is proposed underground, therefore, trees coming in the proposed area have already been added in the enumeration list.

In reply to point No.11, the revised plantation scheme is required to be uploaded against appropriate column and old scheme a/w other irrelevant documents is required to be replaced from the Part-I and Part-II	In this connection, necessary correction has been made and the revised CA scheme has been uploaded in relevant column of Part- II.
7	In reply to point No.12, 13, 15 & 19, the documents stated to have been uploaded with reply but same should be uploaded separately on portal against the additional information detail. Further, old/irrelevant documents are required to be removed from the portal so that relevant documents could be accessed easily.
