Sub: - Proposal for diversion of 6.56 ha. of forest land for construction of Bolangir By-Pass Road (west) by the Executive Engineer, N.H. Division, Bolangir.

Ref: - Memo No. 13052 dt.02.07.2022 of CCF, Forest Diversion & Nodal Officer, FC Act.O/O the PCCF, & HoFF, Odisha, Bhubaneswar.

In inviting a reference to the above cited memo on the captioned subject, the necessary compliance to the shortcomings noticed on the above diversion proposal is submitted as below alongwith the compliance submitted by the user agency for favour of your information and onward transmission.

- 1. The pages of the DP are correctly numbered.
- 2. Land Schedule:- The diversion proposal is for 6.56 ha forest land and 62.59 ha of non-forest land but while scrutinizing the land schedule area of forest land mentioned for Bolangir and Puintala Tahasil is (6.4099 ha + 0.1477 ha) of 6.56 ha. The land schedule of Non-forest (Govt) land of 3.440 acre under Puintala Tahasil submitted by the Tahasildar, Puintala & Non-forest private land of 41.750 acres under Puintala Tahasil notified u/s3(G)of N.H.act. are attached herewith in separate sheet. The total non-forest land under Puintala Tahasil is 45.190 acre or 18.288 ha.and 44.307 ha. under Bolangir Tahasil. Hence the total non-forest land is 62.59 ha. There is No shortfall of 2.124 ha of non-forest land which has been clarified and the details are enclosed.
- 3. **Tree enumeration**: The detailed tree enumeration list of Tahasil wise and village wise for both forest and non-forest land is enclosed herewith.

Trees enumerated on forest land=1507 nos.

Trees enumerated on non-forest land (govt) = Nil

Trees enumerated on non-forest land (Private) =2871nos.

- 4. Alternate Route Alignment: Alternate route alignment study and finalization of route along with map submitted by the user agency is enclosed.
- 5. Non-forest land: The land schedule of Non-forest (Govt) land of 3.440 acre under Puintala Tahasil submitted by the Tahasildar, Puintala & Non-forest private land of 41.750 acres under Puintala Tahasil notified u/s3(G)of N.H.act. are attached herewith in separate sheet.

The total non-forest land under Puintala Tahasil is 45.190 acre or 18.288 ha.and 44.307 ha. under Bolangir Tahasil. Hence the total non-forest land is 62.59 ha.

- 6. Certificate regarding Land schedule as on 25.10.1980: The certificate regarding status of land schedule as per Sabik kissam (25.10.80) received from Tahasildar, Puintala is enclosed herewith.But the certificate of land schedule pertaining to Bolangir Tahasil has not been received from Tahasildar, Bolangir yet.Hence, an undertaking submitted by the User agency is enclosed herewith.
- 7. Undertaking for payment of additional NPV as per proper format submitted by the User agency is enclosed herewith.
- 8. CA Scheme: The CA land copy allotment order by Tahasildar, Bolangir in two phases for 17.00 acres vide letter No.3511 dt.31.8.2021 and 17.29 acres vide; letter No.3438 dt.24.5.2021 is enclosed herewith. The allotment/alienation order from the Collector, Bolangir is awaited. Hence, an undertaking submitted by the user agency is enclosed herewith.
- 9. The length and width of the proposed road alignment passing through forest and non forest land submitted by the user agency is enclosed herewith.
- 10. The GPS co-ordinates of the start point and end point of the road project submitted by the user agency is enclosed herewith.

Two copies of the corrected Diversion proposal alongwith soft copy of the diversion proposal is enclosed herewith for favour of your information and onward transmission.
