In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change (FC Division), New Delhi has requested to furnish compliance to Advisory Committee observations vide letter dated 10.06.2025. The point wise compliance based on the reports of the DFO, Keonjhar Forest Division and RCCF, Rourkela Circle is furnished below:-

Observation No. (i) :- As the user agency i.e. Shri DC Jain is no more and the proposal for change in the name has been submitted by the User Agency through PARIVESH 2.0 portal, vide online id no. FP/OR/MIN/QRY/530182/2025, therefore it would be appropriate that the State Govt. shall first complete the process for approval of change in the name of the User Agency and resubmit the proposal thereafter.

The RCCF, Rourkela Circle has reported that the MoEF & CC, GoI, New Delhi, have accorded approval vide their Letter No. FP/OR/MIN/QRY/530182/2025 dated 26.08.2025 for change in name of the User Agency in respect of approval dated 14.11.2005 granted by MoEF & CC, Govt. of India in favour of M/s Dharam Chand Jain (DC Jain) and the on-going forest land diversion and land use change proposal over 89.961 ha (79.367 ha of fresh forest land diversion and land use change within 10.594 ha of already diverted area) in respect of Dalpahar Iron & Manganese Mines in Keonjhar Forest Division of Keonjhar District to Sri Avin Jain vide proposal No. FP/OR/MIN/QRY/530182/2025 dated 26.08.2025 (copy enclosed as Annexure-I).

I am directed to refer to Government of Odisha letter No. FE-DIV-FLD-0101-2021--13143/FE&CC dated 31.05.2025 seeking approval of the Central Government for change in name of the User Agency in case of subject cited proposals and inform that after careful examination of the proposal of the State Government and the approval of the same by the competent authority in the Ministry, the Central Government hereby accords its approval under sub-section (1) of section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for change in the name of the User Agency in case of approval dated 14.11.2005 granted by MoEF & CC, Govt. of India in favour of M/s Dharam Chand Jain (DC Jain) and the ongoing forest land diversion and land use change proposal over 89.961 ha (79.367 ha of fresh forest land diversion and land use change within 10.594 ha of already diverted area) in respect of Dalpahar Iron & Manganese Mines in Keonjhar Forest Division of Keonjhar District to Sri Avin Jain subject to the following conditions:

3.1	Transfer fee i.e. 10,00,000/- (10 Lakh) will be realized from the new user agency and will be deposited in the CAMPA account.
3.2	Reimbursement of amount paid by the original user agency shall be dealt with in the manner, as provided in the Coal Mines (Special Provisions) Second Ordinance, 2014 and Rules framed thereunder.
3.3	The new user agency shall pay the NPV as per the approval granted under FC Act if not paid earlier. The new user agency shall also furnish an undertaking to pay the additional NPV, if so determined by the Hon'ble Supreme Court of India.
3.4	The State Government shall upload the KML files of the diverted area, CA land on the - Green Watch portal of the Forest Survey of India and details of the same shall be informed to the IRO and Ministry through annual self-compliance report;
3.5	The user agency shall, after ceasing mining operations, undertake re-grassing the mining area, and any other areas which have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna, etc.
3.6	The new user agency shall abide by all the conditions stipulated in the approvals granted to the erstwhile user agency;
3.7	The new user agency shall abide by any other condition that may be stipulated by the Central Government/Regional Offices/State Government with prior approval of the Competent Authority of MoEF&CC, New Delhi in future in the interest of conservation, protection and development of forests and wildlife.
3.8	The user agency shall comply the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project; and
3.9	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.16 of Chapter 1 of the Consolidated Guidelines and Clarifications on Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 as issued by this Ministry's letter dated 29.12.2023.
