Permission of diversion of forest land on which existing LVR is constructed, was accorded by Govt. of Uttar Pradesh vide letter no. L-118/14-3-1990 Dated 27-01-1990. The aforesaid letter is uploaded at serial no. 1 of additional information details of online part I. |
| 4 | The FRA certificate of DM states the date of meeting of DLC as 09-12-2014 while the Gram Sabha date has been mentioned as 19-01-2015. The meeting of DLC could not have preceded the Gram Sabha meeting. This may be reviewed. | FRA certificates have been checked by this office and found to be correct. Date mentioned on certificate of district level committee is 02-02-2015 and on certificate of Gram Sabha is 19-01-2015. Thus, meeting of D.L.C. has not preceded the gram sabha meeting.
