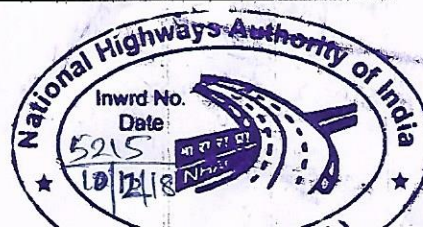

विषयांतर्गत संदर्भित पत्र के परिपेक्ष में भारत सरकार पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय क्षेत्रीय कार्यालय नागपुर के द्वारा प्रकरण में 07 बिन्दुओं की अतिरिक्त जानकारी आवेदक संस्थान द्वारा चाही गई थी। जिसे आवेदक संस्थान द्वारा निराकरण कर इस कार्यालय में प्रस्तुत किया गया है।

पूर्व में भी REC meeting dated 16.10.2018 के द्वारा आवेदक संस्थान से 05 बिन्दुओं में जानकारी चाही गई थी जिसे इस कार्यालय के पत्र क्र. 1102 दिनांक 16.11.2018 के द्वारा प्रेषित की गई थी। बिन्दु क्र 06- 07 की जानकारी प्राक्कलन में भी संलग्न किया गया है। आवेदक संस्थान द्वारा प्रेषित 01 से 07 तक की जानकारी निम्नानुसार प्रेषित है:-

Sl no	Observation	Reply
(i)	The area under existing road has also been included in proposed diversion area and the calculation of the area proposed for diversion is not professionally done. State Government should submit their comments on whether the area under existing road is also sought to be diverted even if road was laid prior to 1980, before Commencement of Forest (Conservation)Act, 1980	Area under existing road also needs to be diverted because they are recorded as Big/small revenue forest trees in Revenue records. These survey numbers are crossing through the existing road & are notified as Big/small revenue forest trees in Gazette notification for land acquisition under NH Act. It is to inform that Competent Authority for land acquisition is SDM Bilaspur as per Gazette Notification Hence, 3A/3D Notification published by CALA, Bilaspur for these survey numbers as Big/small revenue forest trees is nature of land at present. However, These roads are laid after 1980 but since they are still reflected as Big/small revenue forest trees in revenue records, Hence needs diversion.
(ii)	Examination of proposed alignment in Google Satellite imaginary revealed new alignments are proposed over forest land, whereas user agency has maintained that there are no new alignments. Accordingly, State Government should submit the details of new alignments proposed in forest area.	New minor alignments in revenue forest area are due to re-designing of curves, structures at par with Geometric design standards of National Highways. Details of all such location is attached as <u>Annexure A</u> . Total area under re-alignment part is 4.586 Hectare.

(iii)	Area under each patch should calculate conspicuously and same need to be submitted.	Detailed Area statement is attached as <u>Annexure B</u> for forest patches in existing alignment & re-alignment part separately. It is to inform that Since dimensions of patches are not linear hence there is no other way but to average out the width & length of patches by back calculating from Area arrived from GPS coordinates. Hence Area of patches calculated from GPS coordinates is extremely accurate but just for presentation purpose in length & width form by road chainage wise, their average length & width is taken.
(iv)	Details of all structures like bridges, minor bridges, culverts (box culverts or/and underpasses) proposed specifically in forest land may be submitted by State Government.	Details of all structures like bridges, minor bridges, culverts (box culverts or/and underpasses) proposed in forest land is attached <u>Annexure C</u> .
(v)	Examination of revised submitted compliance of schedule Tribe and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 revealed that Gram Sabha Resolutions/ Forest Right Committee(s) proceeding for entire 24.585 ha needs to be submitted for 16 villages and 21.6289 ha area. Gram Sabha Resolution/Forest Rights Committee (s) proceedings for entire 24.585 ha to be submitted.	Gram Sabha Resolutions/ Forest Right Committee(s) proceeding under ecognition of Forest Rights Act, 2006 for all 14 villages for entire 24.585 indexwise is attached as <u>Annexure D</u> .
(vi)	No changes have been made in CB analysis and same CB analysis has been submitted. Revised CB analysis, duly estimating benefits of all parameters by converting them in monetary terms as mentioned in Table-C of MoEF&CC's guidelines dated 01.08.2017, may be submitted by State Government.	Revised CB Analysis as per MoEF&CC's guidelines dated 01.08.2017 is attached as <u>Annexure E</u> .
(vii)	Physical copy of DGPS map has not been submitted.	Physical copy of DGPS map is attached as <u>Annexure F</u> .

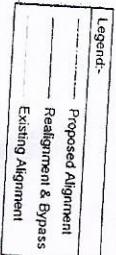
