In obedience to the reference 2nd cited, I herewith resubmit the proposals duly rectifying the omissions / lapses pointed out by the Chief Conservator of Forests, Kurnool for the subject project as follows.

- 1) In Part-II of the proposals at P. No. 11 against item No. 13, the Divisional Forest Officer has requested that the proposals may be accepted instead of recommending the proposals specifically as furnished in online at P. No. 23 against item No. 16.**

It is submitted that, the recommendation of the project in Item No. 13 of Part-II of the proposal has been corrected and rectified as “Recommended, the proposed diversion area for upgradation of paved shoulders to a width of 5.00 mts on either sides over a length of 8.00 Kms to the existing BT road will not have any impact on the flora and fauna. There is no impact of the project on the adjoining forests. There is negligible destruction / damage or diversion of the habitat for flora

and fauna by this project. The proposed area is hilly terrain. Hence the area is recommended for the project as it is connecting two districts and the proposed area is abutting the existing road".

- 2) The P. Nos. are not furnished at Part-II against each item wherever stated to be enclosed should be noted invariable in each set (i.e. from Page No. 5 to 11)**

It is submitted that, the in Part-II of the proposals the page nos. are mentioned against each item and rectified the proposals.

- 3) The soft copy in CD should be enclosed to each set.**

The soft copy in CD is enclosed to each set of the proposal and submitted for perusal.
