Forest diversion proposal for 32.717 ha. of Revenue Forest land in Mouza Harapur, Harekrushnapur, Alkar and Durgapur under Jatani Tahasil in Khordha District for establishment of Infovalley Electronics Manufacturing.


In inviting kind reference to the above cited memo on the captioned subject, as per the inspection report held on 05.05.2025 in presence of the representative of user agency and the outcome, it is reveled that the violation made under the guide lines of the Forest Conservation Act communicated under the referred supra, the inspection over the alleged 09 patches of Forest Land of the inspection relate to violation were furnished below.

1. It is seen that all the 9 patches are coming within the limits of Info valley. Although the IDCO authority stated that 1 point is outside the Infovalley area, but it is revealed that the patch stated outside is coming within the entire project area.
2. The IDCO authority admitted that at 6 patches some roads have been developed for facilitating connectivity inside the Infovalley Project. They also stated that the road is lying in the clear patches in between the cashew plantation raised on the waste land and the road is being used by the villagers like Harapur, but no connecting documents/ photographs could not produce during inspection rather the present status is that the road has been constructed by black top road which sows the clear violation under the prevailing rules,

However, the patches shown by the user agency on site as per the computation of area according to the Kahata No are furnished below.
