Kindly recommend for issuance of Final Forest Clearances for the above-mentioned drilling locations at the earliest, as ONGC is in urgent need of locations for operations.

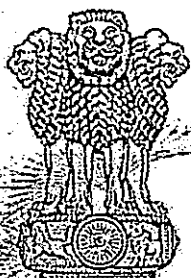

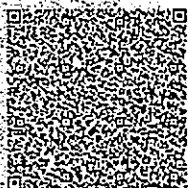

(xix) Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes to comply with the condition that no labor camp will be established on the forest land and no work will be done after sunset.

Whenever operation is required at night time, due prior Permission, from competent authority will be taken.

(xx) Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes to comply to the condition that initially the permission for prospecting will be granted for seven years from the date of issue of this approval which can be extended for one more year with convincing justification from the State Government for extension.

(xxi). Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes to comply to the condition that in case of violations of conditions by the User Agency, the permission for prospecting of minerals shall be suspended by the concerned Divisional Forest Officer. Further it shall be enquired by the Nodal Officer (FCA) of the State Government and report to be submitted to the concerned Regional Office for appropriate action.

(xxiii) Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes to comply to the condition to minimize disturbance to the wildlife, and take all possible measures to minimize noise during prospecting operations and halt the prospecting activities during night and during such periods in the day as may be advised by the concerned Chief Wildlife Warden, concerned State Forest Department.

Whenever operation is required at night time, due prior Permission, from competent authority will be taken.

(xxiv) Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes that this permission shall, in no way, confer any rights to the project proponents or any other agency for grant of approval under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of forest land for any other non-forestry use of the said forest land.

(xxvii) Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes that the period of diversion of the said forest land under this approval shall be for a period coterminous with the period of the mining lease proposed to be granted under the Mines and Minerals (Development and Regulation) Act, 1957, as amended and the Rules framed there-under.

(xxxii) Oil and Natural Gas Corporation Limited (ONGCL), hereby undertakes that any other condition that the concerned Regional Office of this Ministry may stipulate with the approval of competent authority in the interest of conservation, protection and development of forests & wildlife.


