Kindly refer to the EDS raised by Nodal Officer cum Addl. Pr. CCF (FCA) O/o Pr. CCF, H.P. Shimla -1 vide Letter No. Ft. 48-5102/2022(FCA) dated 24.02.2023 on the subject cited above.

2. The point wise reply to the observations furnish as under :-

Sr. No.	Observation	Reply
1.	Reply as submitted vide your above referred communication is found incomplete. No such documents have been found uploaded in the additional information detail in Part-I which certified the possession on 1.5717 hectare of forest land by user agency prior to 1980. If no such documentary evidence is available with the user agency, than it is clear that violation has been done by the user agency, therefore, action on point No. 2 (i). (ii).& (iii) is required to be taken by the Forest Department & reply should accordingly be submitted to this office after taking necessary action.	As submitted by the User Agency, the copy of the Proceeding of the General House Meeting dated 27.08.1977 of the then Municipal Council Dharamshala has been uploaded against the Additional Information and same is enclosed herewith. Further the User Agency has issued a Certificate stating that the retaining wall work has been done on this Muck Disposal Site prior to 1980 and passed in the General House Resolution on 02.09.1977. Hence the site was used for Solid Waste Management prior to 1980 till date. A certificate in this regard has been uploaded against Additional Information Detail in Online Part and I and same is enclosed herewith. The GPS tagged photographs showing the Retaining Wall in depilated condition are also uploaded supplement in the case. It is further submitted that as per facts submitted above, no Action was ever taken in this regard.

It is therefore, requested that the necessary approval for the diversion of 2.9696 ha of forest land for the construction of above mentioned project may kindly be obtained from the Govt. of India under Forest (Conservation) Act, 1980 and conveyed to this office.

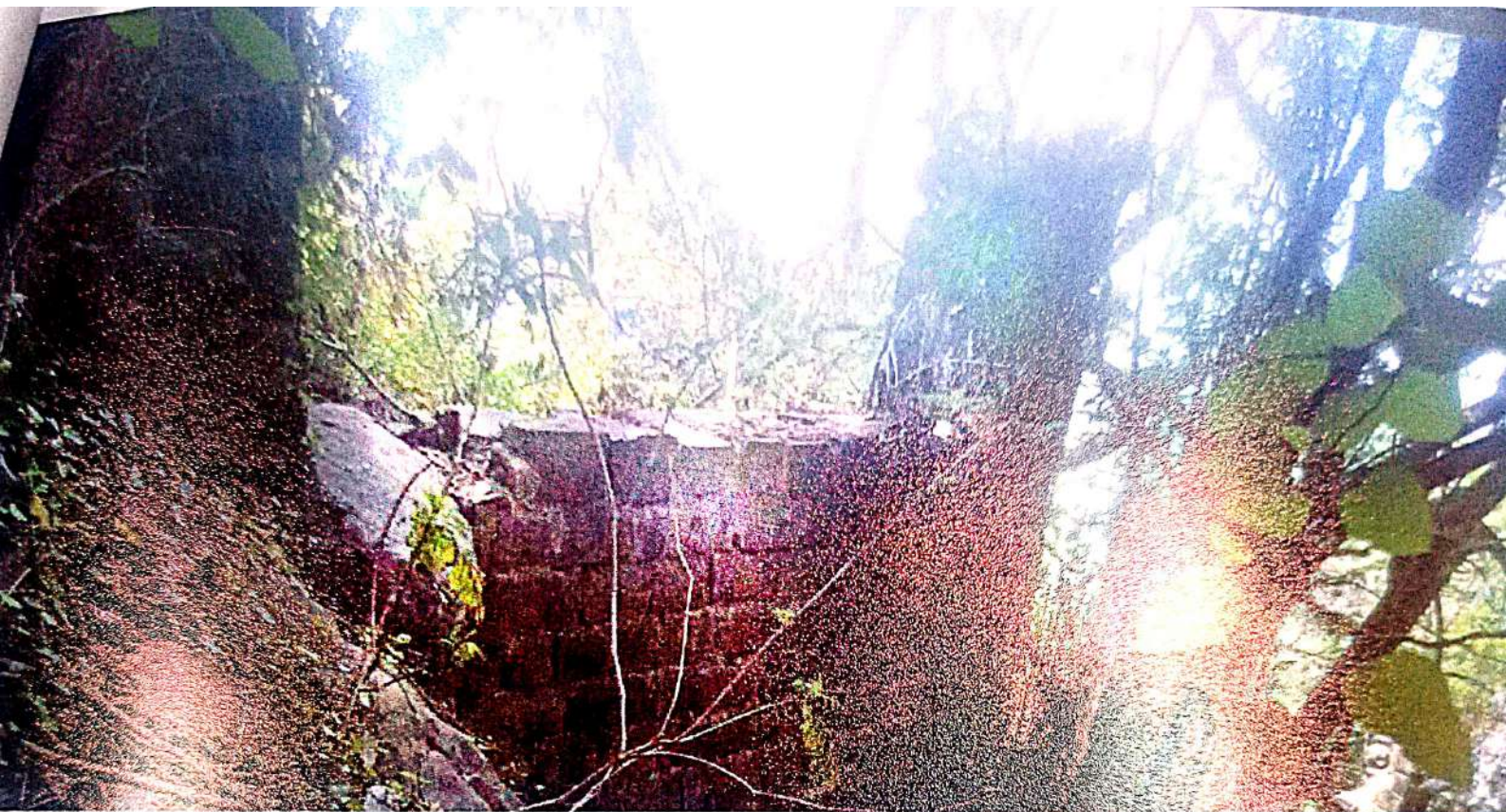
