 - 5. Deputy Conservator of Forests, Chitradurga Division letter No. A6/FC/Yammiganur/29278/CR-45/2017-18 dated 24-01-2020, 17-02-2020 and 06-08-2021 [submission of incomplete

information], 15-03-2023 and 16-11-2023 [submission of revised information to CCF Ballari Circle].

 Chief Conservator of Forests, Ballari Circle letter No. M1/QRY/Road/CR-06/2017-18 dated 20-02-2020, 09-02-2022, 20-03-2023 [submission of incomplete information] and 23-11-2023 [submission of revised information to this office].

With reference to the above subject and the proposal seeking Stage-I approval submitted by this office Government of Karnataka vide Ref (1) letter dated 05-03-2018 and by the State Government vide Ref (2), the Government of India vide Ref (3) letter dated 04-10-2018 had sought certain information on two points and also the details of encroachment in the forest area. The same was communicated by this office vide Ref (1) letter dated 24-11-2018 to the User Agency and Field officers seeking the required information/documents.

However, owing to non-receipt of the information, the Government of India vide Ref (3) letter dated 19-08-2019 has closed the proposal. Accordingly, this office vide Ref (1) letter dated 26-12-2019 communicated the same to User Agency and the field officers seeking a Site Inspection Report to confirm that there is no FC violation in the case.

Meanwhile, the User Agency vide Ref (4) letter dated 03-01-2020 has submitted the required information/documents (FRA Certificate to the Deputy Conservator of Forests, Chitradurga Division requesting to condone the delay in submission of the information. The Deputy Conservator of Forests, Chitradurga Division vide Ref (5) letters dated 24-01-2020 and 17-02-2020 has submitted his reply to the Chief Conservator of Forests, Ballari Circle who has vide Ref (6) letter dated 20-02-2020 has submitted the same to this office.

The same has been examined by this office and found to be incomplete. Hence this office vide Ref (1) letter dated 18-12-2020, 14-10-2022 and 08-09-2023 has directed the DCF Chitradurga to submit a report on the recent development in the FOC cases and site inspection report along with specific remarks.

In response, the Deputy Conservator of Forests, Chitradurga Division has inspected the site on 16-10-2023 and submitted the report to the Chief Conservator of Forests, Ballari Circle. Accordingly, the Chief Conservator of Forests, Ballari Circle vide Ref (6) letter dated 23-11-2023 has agreed with the report of DCF, Chitradurga Division and submitted it to this office.

Based on the reports obtained from the Field officers, the present status of compliance *in respect of conditions of Stage-I approval* is as follows.

1	Alternatives examined	The Deputy Conservator of Forests, Chitradurga Division has inspected the site on 16-10-2023 and stated that there is no other alternate road has been found for seeking the approach road over an extent of 0.692 ha other than the forest land. it is also reported that the other roads are very narrow and passing through the villages and temples which are also existing at the fringes of the alternate roads Besides-this, some of the roads are curved, thus causing a lot of difficulties/hindrance for the movement of the heavy loaded vehicles.		
		As per the request of the user agency, it is found that there is no alternate road except the proposed 0.692 ha of forest land for approach road. Hence, the justification given for diversion of 0.692 ha of forest land for approach road is quite genuine.

The Rang Forest Officer, Holakere has already been instructed to immediately file an appeal against the erroneou grants made by the Assistant Commissioner in th section-4 notified forest land.		
	 All and the second secon	The Range Forest Officer, Holalkere has already booked five different forest offence cases against the user agencies who are carrying out non-forestry activities without obtaining the proper approva under the Forest (Conservation) Act, 1980.		

Further, the Range Forest Officer, Holalkere has already filed an appeal in the court of the Assistant Commissioner, Chitradruga against erroneous grants in the section-4 notified forest land, besides booking the FOC case bearing No.02/2012-13 dated 21-04-2012 itself against the Nirmiti Kendra, Chitradurga and Executive Engineeer, Holalakere for using the forest land for non-forestry activities without obtaining prior approval of the Forest (Conservation) Act, 1980.
