Vide ref 1st cited, the GoI, MoEF & CC, New Delhi has sought additional information on the subject proposal for further consideration of the proposal.

Accordingly, vide ref 2nd cited, the Chief Conservator of Forests, Bhadradri Circle has furnished information as desired by the GoI, MoEF & CC, New Delhi which are furnished as follows, with remarks:

Point No.i:- The State Government and the User Agency shall re-look into the conditions imposed in all the cases wherein Forest Clearance has been sought by the UA and submit in a report to this Ministry as per the decision in the meeting held on 17.04.2023.

Reply: There are total of (63) proposals for which M/s.SCCL has obtained permission for diversion and the SCCL has submitted the annual compliances to the conditions imposed in the approvals of above (63) proposals for the year 2023-24 to the Prl. Chief Conservator of Forests & Nodal Officer, Telangana, with a copy to the Regional Officer, Integrated Regional Office, MoEF&CC, Hyderabad. These proposals are being inspected by the IRO, Hyderabad Office for monitoring of Compliances. (Copies of Compliances enclosed).

Point No.ii:- The UA and State Govt. will re-look into the safety zone issues and submit the proposal for maintaining the safety zone as per this Ministry's guidelines. The State Govt. shall submit proposal and obtain approval under the Forest

(Conservation) Act, 1980 for diversion of forest area located in the safety zone as per this Ministry guideline dt.10.11.2022 as per the decision in the meeting held on 17.04.2023.

Reply: Out of these (63) proposals, for 21 proposals 7.5m safety zone area is required to be maintained outside the diverted forest land to an extent of 45.86 Ha and NPV is to be paid for 45.86 ha. The Prl. Chief Conservator of Forests, Telangana, has requested the concerned Field Officers to examine and to issue demand for depositing of NPV with simple interest of 12% for the 45.86 ha pertaining to above 21 proposals towards the maintenance of safety zone area outside the diverted forest lands prior to the 27.07.2015 and SCCL has been requested to submit the proposals for taking necessary approval as per the guidelines.

For the present proposal of 124 Ha is concerned, initially boundary pillars etc were constructed and maintained. However, as this area was surrounded by other diverted forest lands, this area was mined out completely and now in the process of back filling of the void created and after filling of the voids again boundary pillars were constructed and both side of which plantations were also raised with local species. Now safety zone is maintained out of the void area. The Dy. Inspector General of Forests O/o the IRO, Sub-Office, MOEF & CC, GOI, Hyderabad, has taken up inspection & monitoring of this area and safety zone on 12.09.2023.

Point No.iii:-. The DFL area i.e. 9.31Ha. in which plantation was done wrt the one and half times for safety zone area pertaining to this proposal is falling inside 649.3014Ha forest area proposed for Venkateshkhani OCP (from underground rights to surface rights). This proposal 649.3014ha is under consideration in the Ministry of conversion of UG rights to Surface rights. In this regard the State Govt. is requested to clarify the same.

Reply: Initially, SCCL deposited an amount of 3.66 Lakhs towards plantation in degraded forest land for 1 ½ times of safety zone area on 2.11.1998. The plantation was taken up by the Forest Department in this area of 9.31 Ha. Due to the proposed diversion area, the plantation is lost and SCCL shall pay the amount for raising plantation in alternate DFL site of 9.31 ha as proposed by the Forest department and the same has been agreed by SCCL.

Point no. iv. The State Govt. shall forward the compliance with regard to CA land and status of CA plantation wrt an area 61.66ha identified against non-forest CA lands handed over by M/s. SCCL and later on it was handed over by the I&CADD officials for SRILP Project. The State Govt. shall also submit the copy of notification as per RF/PF wrt the CA land.

Reply: The CA land of 124.00 Ha is part of 233.77 Ha was handed over to Forest Department in Sy.No.116 of Rasannagudem village of Mulakalapally Mandal of erstwhile Khammam district on 06.03.1990 and the same was mutated in favour of Forest Department vide Mandal Revenue Officer, Mulakalapally Rc.No.B/912/97, dt.07.07.1997. The CA area was free from encroachment at the time of handing over. The Revenue department has given the CA land of 61.66 Ha for SRLIP in the year 2018 in the same survey no and the area is overlapped and it was mistake of facts by the Revenue department.

At present no notification was done for this area and the area was inspected by the Dy. Inspector General of Forests O/o the IRO, Sub-Office, MOEF & CC, GOI, Hyderabad, on 12.09.2023.

In view of urgency in grounding of the proposed project of VKOCP which is linked to the present proposal, the SCCL has proposed alternate Non RF land against this land of 61.66 Ha at Mangapet in Mulugu district.

Point no. V:-. The State Govt. informed that the plantation wrt the instant proposal was done in the DFL since the NFL identified was having high density. Therefore, the details of DFL along with the KML file requires submission.

Reply: The details of CA Plantation carried out in alternate degraded Forest land to an extent of 124.00 is as follows:

These CA plantation areas were inspected by the Dy. Inspector General of Forests O/ o the IRO, Sub-Office, MOEF &CC, GOI, Hyderabad, on 11.09.2023 and the map and kml file of DFL areas are enclosed.

Point no. Vi:- The State Govt. shall demarcate and fence the identified new CA land.

Further, the same land shall be mutated in favour of Forest Department and declared as RF/PF as per the condition no 4 imposed by this Ministry vide its approval letter dt.08.02.1999 which states that;- (4) The non-forest land transferred to forest dept. for CA shall be declared protected forest/reserved forest under Indian Forest Act 1927.

Reply: M/s.SCCL has handed over the Non-forest CA land to an extent of 212.04 Ha of to forest department as land bank in Chunchupally, Wadaguda and Ramachandrunipeta villages of Mangapet Mandal vide charge certificate dt. 07.09.2007 and mutated vide Lr No. B/1452/2007 dt. 07.09.2007 by Tahsildar. (Copies of Mutation and Charge certificates are enclosed as annexure-iii). M/s.SCCL shall pay amount for demarcation and fencing of alternate CA land as per scheme prepared by the State forest department after grant of Stage-I for the renewal of 124.00 Ha of GKOCP and the same has been agreed by them. The said land will be notified after getting the Stage-I approval.

Point no.vii:- Accordingly to the reply submitted by the State Govt. the CA area identified initially was free from the encroachment at the time of handing over and encroachments happened in subsequent years. Further, it was stated that out of CA land handed over, only area of 42.96Ha. is available (free from encroachment) and having good forest growth 1 with more than 0.6 density as such no use of any further planting. The remaining area of 81.04 Ha. is under encroachment and it may not be possible to evict the encroachment. In this regard State Govt. should clarify that who is responsible for these encroachment and why no action by the responsible officers was taken against the encroachers as the land was already mutated in favour of the Forest Dept. further the details of the officials responsible for not taking action against the said encroachment along with action taken may be forwarded to the Ministry

Reply: The CA land was handed over to forest department on 06.03.1990 and the encroachment was happened in the subsequent years under influence of Naxals. During the period from 1988 to 2005, Naxal activities were on peak and moreover most of the employees retired long back who were responsible for encroachment and action could not been taken against them.

In view of the above, stating all the above facts the State Government are requested to submit the information to GoI, MoEF& CC, New Delhi for consideration of this proposal.

Adverting to the reference 15th cited above, it is submitted that, the District Forest Officer, Bhadradri Kothagudem vide reference 16th cited above has submitted that, the Principal Chief Conservator of Forests (HoFF), TS, Hyderabad vide reference 15th cited has called for the specific remarks of the District Forest Officer, Bhadradri Kothagudem on the replies to the EDS submitted by the SCCL and the General Manager, M/s. Singareni Collieries Company Limited, Kothagudem area has furnished the revised replies.

In this regard, the District Forest Officer, Bhadradri Kothagudem has submitted that, the following remarks of the District Forest Officer, Bhadradri Kothagudem are submitted as follows.



Point No.i:- The State Government and the User Agency shall re-look into the conditions imposed in all the cases wherein Forest Clearance has been sought by the UA and submit in a report to this Ministry as per the decision in the meeting held on 17.04.2023.

Reply: It is submitted that SCCL obtained diversion of forest land for entire SCCL for its 63 proposals. The SCCL has submitted annual Compliances to the conditions imposed in the approvals of above 63 proposals for the year 2023-24 to the Prl. Chief Conservator of Forests & Nodal Officer, Telangana, with a copy to the Regional Officer, Integrated Regional Office, MoEF&CC, Hyderabad. The Officers, of the Regional Office, Integrated Regional Office, MoEF&CC, Hyderabad, inspected the above diverted Forest lands for monitoring of Compliances. (Copies of Compliances for 63 proposals are enclosed as Annexure-I)


Point No.ii:- The UA and State Govt. will re-look into the safety zone issues and submit the proposal for maintaining the safety zone as per this Ministry's guidelines. The State Govt. shall submit proposal and obtain approval under the Forest (Conservation) Act, 1980 for diversion of forest area located in the safety zone as per this Ministry guideline dt.10.11.2022 as per the decision in the meeting held on 17.04.2023.


Reply: It is submitted that, in all 21 proposals approved, an extent of 45.86 Ha towards 7.5m safety zone area is required to be maintained outside the diverted forest land pertaining to the above proposals and NPV is to be paid for 45.86 ha. Accordingly, vide letter CRP/EST/F/57/661, dated 18.09.2023, the SCCL has requested the Prl. Chief Conservator of Forests, Telangana, to advise the concerned Field Officers to examine and to issue demand for depositing of NPV with simple interest of 12% for the 45.86 Ha towards the maintenance of safety zone area outside the diverted forest lands prior to the 27.07.2015 (copy enclosed as annexure-II).

Regarding Safety Zone of 124 Ha, it is brought to the kind notice that entire area of 124.00 Ha was diverted for quarrying of coal to a depth of 240 meters, besides other two diversions (261.31 ha and 154.96 Ha) obtained. The total area of all these diversions is 540.27 Ha (261.31 +154.96 +124.00) and entire area was for quarrying purpose. The boundaries of all these three diversions are adjacent with common boundaries to each other to the major extent. The outer safety zone of these adjacent boundaries were not maintained due to operational issues like situated in quarry at a depth of 240 Mts, moving of heavy machinery from one area to other for transportation of excavated coal. Moreover, maximum area of these 540.27 ha is lying inside the quarry (Void) of about maximum depth of 240 meters. Hence, in the outer boundary of the remaining area including finished over burden dumps only safety zone can be maintained and boundary pillars can be constructed. Accordingly, 27 number of pillars along the 261.31 Ha, 14 number of pillars along the 124.00 Ha and 26 number of pillars along the boundary of 154.96 Ha are existing.

It is also brought to the kind notice that out of total excavated area of 124 Ha, at present void is 63 Ha and in 61 Ha refilling of overburden has been carried as part of mine closure plan of GKOC, if proposals of VKOC is agreed than in entire area of void as well as refill dump area, OB from VKOC will be dumped upto 70 Mts height from the ground level.

Similarly in area diverted for 154.96 Ha area at present under void is 134 Ha and 20.96 Ha is back filled. In the area diverted for 261.31 Ha area of 140 Ha has been back filled and reaming area 120.31 Ha is void as evident from above, there is no chance to maintain individual safety zone for each project. Hence now plantation in safety zone will be done in left over area. However after approval of VKOC proposal, safety zone will be maintained inside the mining lease within one year.






Photos showing GKOC void areas without Safety Zone.

Further, regarding Payment of NPV for maintenance of Safety Zone of 7.5 Mts outside the diverted forest land, vide Lr No.FC6/FC50/2/2023, dated 03.10.2023, the Principal Chief Conservator of Forests & HoFF, requested the District Forest Officer KGM, to inspect and submit report along with calculation of NPV. Accordingly, inspection was carried out on 19.10.2023 by the District Forest Officer Kothagudem, after receiving

demand for NPV, SCCL will deposit the amount. An undertaking to this effect is submitted herewith.

Along the boundary of 154.96 Ha safety zone of 40 ha plantation was carried out from the year 2011 to 2018 including construction of 26 pillars. These pillars were inspected and reported by the District Forest officer, Kothagudem, vide Rc.No. 52/2016/D1, dated 17.06.2023. Similarly, along the boundary of 261.31 Ha, 27 numbers of pillars were constructed which was also inspected and reported by the District Forest Officer, Kothagudem, vide Rc.No. 62/2023/D1, dated 17.06.2023. Similarly, along the boundary of 124.00 Ha, 14 numbers of pillars were constructed which were also inspected and reported by the District Forest officer, Kothagudem, vide Rc.No. 208/2018/D1, dated 17.06.2023.

The Dy. Inspector General of Forests O/o the IRO, Sub-Office, MOEF &CC, GOI, Hyderabad, has taken up inspection & monitoring of this area and safety zone on 12.09.2023. A photo is attached as below:



Point No.iii:-. The DFL area i.e. 9.31Ha. in which plantation was done wrt the one and half times for safety zone area pertaining to this proposal is falling inside 649.3014Ha forest area proposed for Venkateshkhani OCP (from underground rights to surface rights). This proposal 649.3014ha is under consideration in the Ministry of conversion of UG rights to Surface rights. In this regard the State Govt. is requested to clarify the same.

Adverting to the reference 15th cited above, it is submitted that, the District Forest Officer, Bhadradri Kothagudem vide reference 16th cited above has submitted that, the Principal Chief Conservator of Forests (HoFF), TS, Hyderabad vide reference 15th cited has called for the specific remarks of the District Forest Officer, Bhadradri Kothagudem on the replies to the EDS submitted by the SCCL and the General Manager, M/s. Singareni Collieries Company Limited, Kothagudem area has furnished the revised replies.

In this regard, the District Forest Officer, Bhadradri Kothagudem has submitted that, the following remarks of the District Forest Officer, Bhadradri Kothagudem are submitted as follows.

<u>Point No.i:</u> The State Government and the User Agency shall re-look into the conditions imposed in all the cases wherein Forest Clearance has been sought by the UA and submit in a report to this Ministry as per the decision in the meeting held on 17.04.2023.

Reply: It is submitted that SCCL obtained diversion of forest land for entire SCCL for its 63 proposals. The SCCL has submitted annual Compliances to the conditions imposed in the approvals of above 63 proposals for the year 2023-24 to the Prl. Chief Conservator of Forests & Nodal Officer, Telangana, with a copy to the Regional Officer, Integrated Regional Office, MoEF&CC, Hyderabad. The Officers, of the Regional Office, Integrated Regional Office, MoEF&CC, Hyderabad, inspected the above diverted Forest lands for monitoring of Compliances. (Copies of Compliances for 63 proposals are enclosed as Annexure-I)

Point No.ii:- The UA and State Govt. will re-look into the safety zone issues and submit the proposal for maintaining the safety zone as per this Ministry's guidelines. The State Govt. shall submit proposal and obtain approval under the Forest (Conservation) Act, 1980 for diversion of forest area located in the safety zone as per this Ministry guideline dt.10.11.2022 as per the decision in the meeting held on 17.04.2023.

Reply: It is submitted that, in all 21 proposals approved, an extent of 45.86 Ha towards 7.5m safety zone area is required to be maintained outside the diverted forest land pertaining to the above proposals and NPV is to be paid for 45.86 ha. Accordingly, vide letter CRP/EST/F/57/661, dated 18.09.2023, the SCCL has requested the Prl. Chief Conservator of Forests, Telangana, to advise the concerned Field Officers to examine and to issue demand for depositing of NPV with simple interest of 12% for the 45.86 Ha towards the maintenance of safety zone area outside the diverted forest lands prior to the 27.07.2015 (copy enclosed as annexure-II).

Regarding Safety Zone of 124 Ha, it is brought to the kind notice that entire area of 124.00 Ha was diverted for quarrying of coal to a depth of 240 meters, besides other two diversions (261.31 ha and 154.96 Ha) obtained. The total area of all these diversions is 540.27 Ha (261.31 +154.96 +124.00) and entire area was for quarrying purpose. The boundaries of all these three diversions are adjacent with common boundaries to each other to the major extent. The outer safety zone of these adjacent boundaries were not maintained due to operational issues like situated in quarry at a depth of 240 Mts, moving of heavy machinery from one area to other for transportation of excavated coal. Moreover, maximum area of these 540.27 ha is lying inside the quarry (Void) of about maximum depth of 240 meters. Hence, in the outer boundary of the remaining area including finished over burden dumps only safety zone can be maintained and boundary pillars can be constructed. Accordingly, 27 number of pillars along the 261.31 Ha, 14 number of pillars along the 124.00 Ha and 26 number of pillars along the boundary of 154.96 Ha are existing.

It is also brought to the kind notice that out of total excavated area of 124 Ha, at present void is 63 Ha and in 61 Ha refilling of overburden has been carried as part of mine closure plan of GKOC, if proposals of VKOC is agreed than in entire area of void as well as refill dump area, OB from VKOC will be dumped upto 70 Mts height from the ground level.

Similarly in area diverted for 154.96 Ha area at present under void is 134 Ha and 20.96 Ha is back filled. In the area diverted for 261.31 Ha area of 140 Ha has been back filled and reaming area 120.31 Ha is void as evident from above, there is no chance to maintain individual safety zone for each project. Hence now plantation in safety zone will be done in left over area. However after approval of VKOC proposal, safety zone will be maintained inside the mining lease within one year.

Further, regarding Payment of NPV for maintenance of Safety Zone of 7.5 Mts outside the diverted forest land, vide Lr No.FC6/FC50/2/2023, dated 03.10.2023, the Principal Chief Conservator of Forests & HoFF, requested the District Forest Officer KGM, to inspect and submit report along with calculation of NPV. Accordingly, inspection was carried out on 19.10.2023 by the District Forest Officer Kothagudem, after receiving

demand for NPV, SCCL will deposit the amount. An undertaking to this effect is submitted herewith.

Along the boundary of 154.96 Ha safety zone of 40 ha plantation was carried out from the year 2011 to 2018 including construction of 26 pillars. These pillars were inspected and reported by the District Forest officer, Kothagudem, vide Rc.No. 52/2016/D1, dated 17.06.2023. Similarly, along the boundary of 261.31 Ha, 27 numbers of pillars were constructed which was also inspected and reported by the District Forest Officer, Kothagudem, vide Rc.No. 62/2023/D1, dated 17.06.2023. Similarly, along the boundary of 124.00 Ha, 14 numbers of pillars were constructed which were also inspected and reported by the District Forest officer, Kothagudem, vide Rc.No. 208/2018/D1, dated 17.06.2023.

The Dy. Inspector General of Forests O/o the IRO, Sub-Office, MOEF &CC, GOI, Hyderabad, has taken up inspection & monitoring of this area and safety zone on 12.09.2023. A photo is attached as below:



Point No.iii:-. The DFL area i.e. 9.31Ha. in which plantation was done wrt the one and half times for safety zone area pertaining to this proposal is falling inside 649.3014Ha forest area proposed for Venkateshkhani OCP (from underground rights to surface rights). This proposal 649.3014ha is under consideration in the Ministry of conversion of UG rights to Surface rights. In this regard the State Govt. is requested to clarify the same.

Reply: It is to submit that SCCL deposited an amount of 3.66 Lakhs towards plantation in degraded forest land for 1 ½ times of safety zone area on 02.11.1998. The plantation was taken up by the Forest Department in this area of 9.31 Ha well before to the application submitted by the SCCL for diversion of 649.3014 ha for Venkatesh Khani OCP. However, SCCL agrees to pay the amount for raising plantation in alternate DFL site of 9.31 ha to be identified by the Forest department. An undertaking to this effect furnished by the SCCL is submitted herewith. The alternate suitable area of 9.31 Ha will be identify and CA scheme will be prepared and will be submitted accordingly.

Point no. iv:- The State Govt. shall forward the compliance with regard to CA land and status of CA plantation wrt an area 61.66ha identified against non-forest CA lands handed over by M/s. SCCL and later on it was handed over by the I&CADD officials for SRILP Project. The State Govt. shall also submit the copy of notification as per RF/PF wrt the CA land.

Reply: It is submitted that the CA land of 124.00 Ha (part of 233.77 Ha.) was handed over to Forest Department in Sy.No.116 of Rasannagudem village of Mulakalapally Mandal of erstwhile Khammam district on 06.03.1990 and the same was mutated in favour of Forest Department vide Mandal Revenue Officer, Mulakalapally Rc.No.B/912/97, dt.07.07.1997. The CA area was free from encroachment at the time of handing over.

The I&CAD department has given the overlapped CA land of 61.66 Ha for SRLIP in the year 2018. This was by mistake of facts by the Revenue department. No notification was done for this area. This area was inspected by the Dy. Inspector General of Forests O/o the IRO, Sub-Office, MOEF&CC, GOI, Hyderabad, on 12.09.2023. The SCCL has proposed alternate Non RF land against this land of 61.66 Ha at Mangapet in Mulugu district.

<u>**Point no. V:-**</u> The State Govt. informed that the plantation wrt the instant proposal was done in the DFL since the NFL identified was having high density. Therefore, the details of DFL along with the KML file requires submission.

Reply: It is submitted that the CA land of 124.00 Ha was handed over to Forest Department in Sy.No.116 of Rasannagudem village of Mulakalapally Mandal of erstwhile Khammam District on 06.03.1990. SCCL has deposited an amount of Rs.49,60,000/- for CA scheme. Due to high density of tree growth existing in the said area, CA Plantation was carried out in alternate degraded Forest land at following places.

The KML files of these four plantations were submitted to the DIG, O/o IRO, Sub office, MoEF&CC, Hyderabad, who has inspected these areas on 11.09.2023. <u>All the KML files are enclosed.</u>

<u>Point no. Vi:-</u> The State Govt. shall demarcate and fence the identified new CA land. Further, the same land shall be mutated in favour of Forest Department and declared as RF/PF as per the condition no 4 imposed by this Ministry vide its approval letter

dt.08.02.1999 which states that:-

(4) The non-forest land transferred to forest dept. for CA shall be declared protected forest/reserved forest under Indian Forest Act 1927.

Reply: It is to submit that an extent of 212.04 Ha of Non Forest land was handed over to Forest department as land bank in Chunchupally, Wadaguda and Ramachandrunipeta villages of Mangapet Mandal. This land was handed over vide charge certificate dt. 07.09.2007 and mutated vide Lr No. B/1452/2007 dt. 07.09.2007 by Tahsildar to the Forest department (Copies of Mutation and Charge certificates are enclosed as annexure-III). The SCCL agrees to pay amount for demarcation and fencing of alternate CA land as per scheme as will be prepared by the State forest department after grant of Stage-I for the renewal of 124.00 Ha of GKOCP. The land will be notified accordingly after getting the Stage-I.

This alternate CA area was inspected by the Dy. Inspector General of Forests O/o the IRO, Sub-Office, MOEF&CC, GOI, Hyderabad, on 10.09.2023. The District Forest Officer, Mulugu, has submitted his remarks on this land to the Principal Chief Conservator of Forests & Nodal Officer, TS. KML file of this area is enclosed.

Point no.vii:- Accordingly to the reply submitted by the State Govt. the CA area identified initially was free from the encroachment at the time of handing over and encroachments happened in subsequent years. Further, it was stated that out of CA land handed over, only area of 42.96Ha. is available (free from encroachment) and having good forest growth with more than 0.6 density as such no use of any further planting. The remaining area of 81.04Ha. is under encroachment and it may not be possible to evict the encroachment. In this regard State Govt. should clarify that who is responsible for these encroachment and why no action by the responsible officers was taken against the encroachers as the land was already mutated in favour of the Forest Dept. further the details of the officials responsible for not taking action against the said encroachment along with action taken may be forwarded to the Ministry

Reply: It is submitted that the CA land of 124.00 Ha was handed over to Forest Department in Sy.No.116 of Rasannagudem village of Mulakalapally Mandal of erstwhile Khammam District on 06.03.1990. The encroachment happened in the subsequent years under influence of Naxals (Extremists) as during the period 1988 to 2005 Naxal activities were on peak and moreover most of employee retired long back who were responsible for encroachment, hence action could not be taken against them.

In this regard, the District Forest Officer, Bhadradri Kothagudem has requested to forward the above information, Map & Kml file details to the Principal Chief Conservator of Forests (HoFF), TS, Hyderabad.

Therefore, based on the report of the District Forest Officer, Bhadradri Kothagudem,

the specific remarks of the District Forest Officer, Bhadradri Kothagudem on the replies to the EDS submitted by the SCCL as called for by the Prl.Chief Conservator of Forests (HoFF), Telangana, Hyderabad along with Map & KML file details are submitted to the Prl.Chief Conservator of Forests (HoFF), Telangana, Hyderabad for favour of kind perusal.

This is submitted for favour of kind information and necessary action.

Kind attention is invited to the subject cited, it is to bring to the kind notice that vide reference 1st cited, the MoEF&CC, GoI issued guidelines based on the recommendations of the Advisory Committee, regarding maintenance of safety zone areas falling outside the forest areas for the diverted forest lands prior to 27.07.2015. as follows:

- (i) To enable various user agencies to align their forest land located in the safety zone with the relevant provisions of the guidelines issued by the Ministry, last opportunity is hereby provided by the Ministry by opening a window for the user agencies to deposit NPV by 31.03.2023 along with simple interest of 12% w.e.f. 1.04.2018 onwards till the deposit is made.
- (ii) The user agency should submit proposal and obtain approval under the Forest (Conservation) Act, 1980 for diversion of forest area located in the safety zone by 30.09.2023.
- (iii) In case of failure of compliance of recommendations, mentioned under (i) and (ii) above, possession of forest land located in the safety zone will be considered as violation of the FC Act, 1980 and appropriate penalties will be imposed on defaulting user agencies.
- (iv) The IRO's concerned will monitor the compliance in the matter and submit six monthly report to the Ministry.

Further, vide reference 2nd cited, requested the C&MD, SCCL to pay NPV an to submit the proposals and obtain approval under the Forest Conservation Act, 1980 for diversion of wherever required, along with list of 31 Nos forest diversions obtained in M/s SCCL prior to 27.07.2015 (Copy enclosed).

Accordingly, the proposals were scrutinized and out of 31 proposals, the MoEF&CC. Gol placed condition in 18 proposals (granted before 27.07.2015) for maintenance of safety zone of 7.5mts outside the diverted forest land for which NPV has to be paid.

Further, vide reference 8-73/2005-FC (Vol.I) dt.04.05.2016, 33.58 ha of forest land diverted for MNG OCP after 27.07.2015 in which condition exists for maintenance of 7.5 mtrs strip also included. Further, Two proposals were included as they are clubbed with other proposals.

After scrutiny of above 21 proposals(18 proposals with safety zone condition, 2 proposals under cluster and 1 proposal granted after 27.07.2015), an extent of 45.86 Ha towards 7.5m safety zone area is required to be maintained outside the diverted forest land pertaining to the above proposals and NPV is to be paid for 45.86 ha.

However, the SCCL had maintained Safety zone plantation of 7.5mtrs inside the project wherever possible in the above proposals. The proposal wise details of diverted FLs. Safety zone to be maintained outside the FL along with plan are furnished in Annexure.

Hence, it is requested advise the concerned to examine and to issue demand for depositing of NPV with simple interest of 12% for the 45.86 ha pertaining to above 21 proposals towards the maintenance of safety zone area outside the diverted forest lands prior to the 27.07.2015.
