1	a) The proposal is silent about earlier approval accorded by MoEF and compliance of its condition (B-1 part I is blank) b) Whether overlap in counting of trees with earlier approval exists or not.	As per observation , detail of earlier approval proposal accorded by MOEF is also uploaded in online part –I additional document.
2	As per GIS DSS analysis of proposed forest land for diversion following issues need rectification: a) The original SOI Topo Sheets of proposed forest land to be diverted have not been submitted with the project proposal. b) All key geo coordinates of proposed forest land for diversion have not been provided with the proposal. c) Kml files of proposed forest land for diversion show shift. d) In some of the patches of proposed compensatory afforestation when overlaid on Google Earth show existence of permanent structure, roads etc. e) Around 59 ha of proposed compensatory afforestation patches fall in MDF category and their suitability in CA sites needs a relook. f) Net suitable proposed CA area is having less extent.	As per GIS DSS analysis , change the DGPS map with key point and KML file uploaded in online part - 1 And for the observation of CA land , the certificate of Ca land suitability is also available in Online part –II . In which certificate , also showing that no any structure and road are available in patches of compensatory afforestation . As per observation point 2 (e) , the suitability certificate is uploaded in online part-II .

9	NPV calculation shall be based on revised crown density.	NPV calculation based on crown density changed in online part-II.
