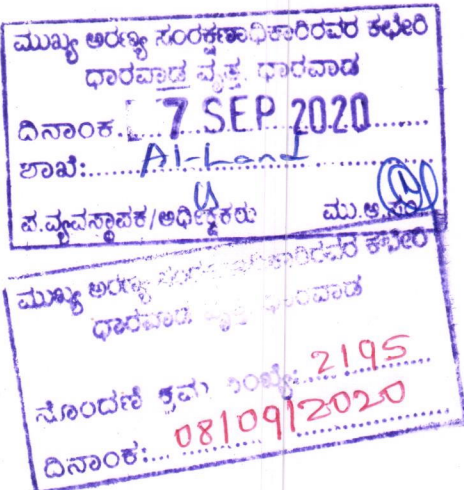

Please ensure that individual Division -wise (including Dandeli Wildlife Division), Village-wise as well as Survey Number-wise breakup of Forest land involved in the proposal is uploaded in the Additional Information Details and provided in ink Signed hard copies (minimum 3 set for this office). Please ensure CA land Suitability Certificates are in the format prescribed by this office vide letter NO. KFD/HOFF/A54(FC)/1/2019-FC DATED 15-05-2019. It is also to be noted that the date of inspection by DCF has to be mentioned in the said Certificate. 	2. As per ICT observation, the CA land proposed in Belagavi Division is also falling in Sy no.176 of Kalkati village. Similarly, as per ICT observations, The CA land proposed in Haliyal Division falls in Mandihal Village Sy NO,46,47,48,59 &60 instead of Sy No.34,36,37,38 & 44. 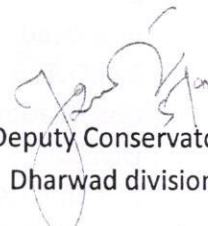

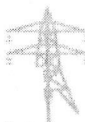

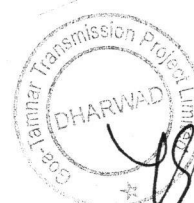
