At the outset the District Collector & Chairperson for District Level Committee under RoFR Act, 2006 welcomed all the members for the meeting. The Executive Engineer, Construction Division, TS TRANSCO Adilabad has informed that the TS TRANSCO, vide T.O.O (CE-Construction/400KV) MS No. 161, Dt 21.08.2012 has accorded approval for construction of 220/132KV Sub-station at Utnoor in Adilabad district to provide reliable and quality power supply with good voltage profile and to have alternate grid connectivity to entire Adilabad Dist.

In this connection, it is proposed to construct 220KV DC line from the proposed 400/220KV SS Nirmal to the proposed 220/132KV SS Utnoor (Adilabad District). For this, necessary route survey has been conducted and it is found that the above line shall be erected through the Jam Reserve Forest area of Nirmal Forest Division situated in Sarangapur Revenue Mandal of Nirmal District for which the forest land over an extent of 9.7887 Ha. is required and requested to issue FORM-I certificate under Forest Rights Act for linear project as per MoEF's Letter No 11-9/98 - FC (pt), dated: 03.08.2009 read with MoEF's letter, dated:05.02.2013.

Accordingly, on the request of TS TRANSCO the concerned Gram Panchayath (Sarangapur Gram Panchayat of Nirmal District) has convened the meeting of Gram Sabha on 02.07.2018 under the chairmanship of the Sarpanch along with the chairman, Forest Rights Committee under RoFR Act, 2006 and unanimously passed resolution stating that there is no objection for diversion of the proposed forest land for the said purpose as there are no encroachments by tribal people in the land to be diverted and further resolved that there are no pending RoFR claims to be settled under the Forest Rights Act.

Based on the resolutions passed by the Grama-panchayath in Grama Shabha, Sub-Divisional level committee, Nirmal has also passed resolution during the Sub-Divisional Level Committee meeting convened on 05.09.2018 stating that there are no objections regarding the diversion of forest land measuring to an extent of 9.788 Ha. in the above mentioned Reserve Forest pertaining to Nirmal division for the said purpose.


The Tahsildar, Sarangapur has also enquired and noticed that the proposed erection of Transmission line is passing from Nirmal to Indravelly through Jam Reserve Forest situated in Sarangapur Revenue Mandal and the Gram Panchayat of Sarangapur has also passed a resolution stating that there are no RoFR pattas granted in the said area and the entire area comes under Forest area of Sarangapur Mandal and also no RoFR claims are pending to be settled in the said proposed area.

Therefore, based on the resolutions passed by Sarangapur Gram Panchayath and Sub-Divisional Level Committee under FRA, the District Level Committee, Nirmal under the Chairmanship of the District Collector unanimously resolved that there is no objection regarding the diversion of forest land measuring an extent of 9.7887 Ha in Jam Reserve Forest of Nirmal Division in favour of the Superintendent Engineer, OMC. TS TRANSCO, Adilabad Circle for construction of 220KV DC line from the proposed 400/220KV SS Nirmal to the proposed 220/132KV SS Utnoor (Adilabad District) and issue a certificate in Form-I under Forest Rights Act.
