ACTION TAKEN REPORT

13. Remarks of Range Forest Officer

During the site inspection on dated 06/10/2021 and after verification document of the proposed project, it has been noticed that the violation is done in the year 2019. The person attended of MSETCL Kalyan mentioned in his statement that violation is done unknowingly and unfortunately. As public interest project it is requested to the project proponent to bear necessary penal amount total number of two towers foundations in the protected forest area. which project authority shall compensate cost against forest land violated. Considering public interest project and its benefits to the area of Mumbai & suburban area, it also helps 24x7 supply of electricity to the region. The Range forest officer Bhatane has booked a POR vide no. RA.GU.No. 09/E/2021-22 Dated 07/10/2021 against the project proponent for the violation work done by project proponent. Being linear project so cost of compensatory afforestation shall be twice the area to the extent of forest land involved under proposal i.e. $2 \times 4.1397 = 8.2794$ ha. Further additional penal cost for C.A. shall be 10 Ha. Hence the total cost of C.A shall be calculated as per 18.2794 Ha. Area which should be made mandatory to compensate by the project authority

A note regarding the circumstances under which the work has been undertaken in violation of forest (Conservation) Act 1980.

MSETCL, Government of Maharashtra undertaking company has proposed to take up the work of construction of 220 KV M/C LILO on 220 KV Tarapur – Borivali and Boisar – Ghodbunder transmission line Taluka Vasai Dist. 4. 24X 7 availability of Power Supply/ Electricity.
5. Provision of continuous power supply to all industries and farmers hence enhancing the GDP of Maharashtra.
6. It provides stability to voltage of Mumbai regions.

During the site inspection on dated 06/10/2021 it is observed that the violation has been done in the year 2019 for which project authority shall compensate against forest land violated, further said project is a linear project so cost of compensatory afforestation shall be twice the area to the extent of forest land involved under proposal i.e. $2 \times 4.1397 = 8.2794$ ha. Further additional penal cost for C.A. shall be 10 Ha. Hence the total cost of C.A shall be calculated as per 18.2794 Ha. Area which should be made mandatory to compensate by the project authority.



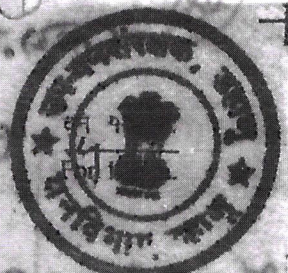
