vi	English translated copy of proceeding of Nagar Panchayat is not submitted.	The English translated copy of proceeding of Nagar Panchayat, Saoli is enclosed herewith as (Annexure No.V.)
vii	Details of alternative alignment explored along with map and Justification for selecting the proposed alternative, Reasons for discarding other alternatives and Justification establishing for inescapability for locating the project in forest area is not submitted.	The Chief Conservator of Forests (T), Chandrapur in his compliance report has stated that the said prposed zudpi jungle is located in Saoli village and it is surrounded by private ownership area, and this area was likely to be encroached in the future. The area has been selected as well as the non-availability of suitable non forest land for the Forest Rest House. The required roads, electricity, water and other essential facilities are available in proposed area and this area is located in village. Hence, the aforesaid condition may not be applicable in the instant case.
viii	Employment Potential likely to be generated in terms of Skilled, Semi- Skilled and Unskilled persons/ mandays by implementation of the project is not mentioned properly.	Unskilled persons/mandays by implementation has been mentioned by the DFO, Chandrapur in his compliance report.
ix	Details on progressive CA done till date in the Division is not mentioned by Deputy Conservator of Forests, Chandrapur in his Part-II. Revised Part-II may be submitted by the DCF concerned.	Division is mentioned by Divisional Forest Officer, Chandrapur in his revised Part-II submitted herewith as (Annexure No.VI).

In view of the above, it is requested that the Government of India may kindly be moved for approval under section-2 (ii) of the Forest (Conservation) Act-1980, at the earliest.
