

It is noticed that, the User Agency i.e. the Dy. General Manager (Elect.), EHT (Construction) Division, OPTCL, Jeypure has constructed 4 Nos. of Web Towers in Tarlakotta PRF & 1 No. of Web Tower in Revenue Forest Land during the period from 31.03.2018 to 22.09.2021 without any prior approval of the competent authority. As the Tarlakota PRF comes under the Somanathpur beat of Somanathpur Section and neither you have taken any action against the User Agency nor intimated regarding use of forest land for non-forestry purpose to the higher authorities for further action against the User Agency as per Rule.



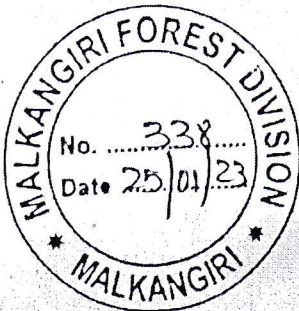
