DCF Kinnaur has intimated that in the last FAC dated 20.10.2023 it was discussed that against the CAT Plan amount of Rs. 70.195 Crore only 50 lacs has been utilized. It is submitted that this statement is not correct. DCF Kinnaur has reported that out of Rs 70.195 Crore the Physical and Financial Progress report to the tune of Rs. 35.35 Crore has been uploaded as additional information on online Part-I Sr. No. 39 & 41 by the user agency. It is further submitted that utmost efforts are being taken to speed up the progress in implementation of CAT Plan & CA. So far as failure of the Compensatory Afforestation plantation in one patch is

There is a voilation over an area of 0,5883 ha. as reported by the State. The detailed justification for violation and action taken report against those responsible for violation shall be submitted by the State.

concerned, it is submitted that the area in question is quite rocky, and near to the habitation. The failure of plantation is due to grazing and draught which will be replanted from the provisions of yearly maintenance cost kept.

DCF Kinnaur has intimated that after getting the approval for diversion of 63 Ha. area under FCA 1980, HPPCL awarded the construction work to M/s Patel Engineering Ltd. The work was started at different sites i.e. HRT, Power House, Surg Shaft and approach road etc. During the construction phase some boundary pillars got damaged due to which the actual boundary could not be ascertained and inadvertently construction of approach road to SFT was constructed beyond the proposed area. As the Forest Department raised the objection regarding the construction of said road and re-demarcation conducted on site as per earlier diversion and it was found that some part of the construction has been executed beyond the boundary of the diverted area and construction activities has been stopped by the Contractor. As it is the essential part of the project due to enhancement of the capacity of the project new proposal for diversion of forest area along with violated area i.e. 0.5883 ha. has been prepared. The violation of 0.5883 ha. was not executed deliberately but was a mistake for which HPPCL is agreed for paying penal NPV or any other penalty by GoI. The General Manager of the Contracting agency Sh. P.P. Sharma, General, Manager (M/s PEL) has got retired and HPPCL take the sole responsibility of the violation and ready to pay the penalty raised against the violation.

4. Point No. IV

The reservoir to be created due to dam construction and subsequent submergence is required to be declared as Reserve Forest under Indian Forest under Indian Forest Act. 1927. A copy of notification for the same shall be submitted.

DCF Kinnaur has intimated that the process for declaring/ notifying the submerged area as Reserve Forest under Indian Forest Act, 1927 has been initiated. The entire Reservoir area has been constituted as Reserve Forest Vide Notification No FFE-B-F014/1/2023
