Once the Wildlife Management Plan receives approval from the competent authority, we will submit the finally approved Wildlife management Plan.

The Wildlife Management Plan for the proposed project has been duly submitted to the Divisional Forest Officer (DFO), Hazaribagh West Forest Division, and is currently under review. We shall submit the same once the Wildlife Management Plan is approved from the CWLW, Jharkhand. Undertaking in this regard is attached as annexure-I.
2	REC pointed out that since felling of trees (Sl. No.14) and Raising of Electric Towers (Sl. No.16) are the Regulatory activities in the Eco Sensitive Zone (ESZ) notification order dated August 01, 2019 of Govt. of India, hence it desired a copy of the Zonal Master Plan from State Govt. if made any. Further, the committee emphasized that User Agency should follow the provisions made in the Master Plan, if prepared. Therefore, an undertaking from user agency to the effect may be submitted.
