

3	Specific recommendation of concerned Conservator of forests for acceptance or otherwise of the proposal with detail reasons	The proposal may be accepted as per guideline of Govt. of India as the Forest land proposal for diversion of 0.028 hac of Forest land is essentially required for construction of 40 mtr span Motor able Bridge over synthen Nallah of Watsar to Dangar Nallah Road KM 2 nd RD (140-190) in the UT of J&K of Marwah Forest Division. As the proposal recommended for forest clearance under section-2 of Forest Conservation act, 1980. The construction of Bridge over synthen Nallah of Watsar to Dangar Nallah road is essentially required for smooth vehicular movement and presentably the said road is connected with culvert which is not suitable for vehicular movement. Submitted by Divisional Forest Officer Marwah is recommended to be accepted.

1.	SOI map indication CA site, as the uploaded map is not accessible	SOI map indicating CA site has been reuploaded.
2.	Undertaking regarding muck disposal in road itself or detailed muck disposal plan.	The User Agency has submitted an undertaking regarding Muck disposal whereas the User Agency has undertaken that the nominal quantity of Earth work is involved in the case and the Muck shall be utilized/disposed off properly in the approaches of the bridge and making of berms/shoulders of road. The undertaking with respect to Muck disposal has been uploaded by User Agency in additional information in part-I and the same has been also uploaded in additional documents of part-II as well.
3.	Comments from the CWLW in view of fauna mentioned at 8 (i) of Part-I.	The road from Watsar to Dangarnallah has been already constructed which is connected over Synthen Nallah by a Culvert and now the User Agency has proposed to construct 40 mtr span motorable bridge over Synthen Nallah for which an area of 0.028 ha is required for site abetment and approach road in right bank/Dangarnallah.
4.	Revised Site Inspection Report from DFO in view of (iii) above, as the site inspection doesn't reflect the fact at (iii) above.	Sometimes, some species of fauna like monkeys, black bear, leopard, jackal etc are seen in the upper reaches of the area. Moreover the area to be diverted neither falls in the National Park nor eco sensitive zone.
5.	Specific recommendation from DFO and CF as per format under part-II and III of the Appendix (Rule 6) of Handbook of Forest (Conservation) Act, 1980 and Forest (Conservation) Rules, 2003 (Guideline and Clarification), 2019: (page no: 25-27)	Specific recommendation has been uploaded in additional documents in part-II.
6.	Description under (A) CA scheme is not clear. Revised CA scheme may be submitted for the number of plants required to be planted clearly.	CA Plan and approval/Sanction for compensatory afforestation to be done in lieu of diversion of 0.028 ha of land has been reuploaded.
