

With reference to the above subject & reference, CA area identified in Halalli Sy No.66 of Athani taluk receives average annual rain fall of 538-559 mm and has very little natural vegetation, Keeping the above factors in mind, Big size poly bags ie 14*20 with 1*1*1 m pit size is chosen to be suitable for planting. This along with watering provisions that is included within the datasheet, soil & moisture conservation measures and overall protection in terms of chain link fencing can result in raising good plantation & forest in future.

Hence, The CA scheme proposed now from this office meets the silvicultural requirement for afforestation in dry area.
