In responding to the Govt. of India's letter cited at Ref (1) & (2), Deputy Conservator of Forests Karwar has submitted a report vide at Ref (4) (copy enclosed) that Chief General Manager (Tech) and Regional Officer, National Highway Authority of India, Bangalore has submitted vide his letter cited at Ref(3) that the project 4/6 laning of Goa Karnataka Border Kundapur section of NH-66 (Formely NH-17) (Km. 93.700 to Km 283.300) is being executed/ executing under (DBFOT by concessionaire M/s IRB West coast Tollway Private Limited, Mumbai. The Independent engineer was AECOM Asia Company Limited in Association with Rodic consultant Pvt. Ltd., for supervision and monitoring of works to be executed. They are represented by the team leader and resident Engineer at site as Engineer-in-charge for the works.

Further, the NHAI stated that, the construction of toll plaza was carried out as per the working permission issued by project sea bird Authority in the forest area which was earlier diverted to Project Seabird.

9.20 ha of forest land which was diverted to project seabird was re-diverted to NHAI for four laning of National highway-66. The MoU was signed by officials of NHAI and project seabird on 10.11.2017. In the present case the toll plaza was constructed in part of forest land which was earlier diverted to Project seabird. Inadvertently the NHAI concessioner started construction of toll plaza thinking that this was part of 9.20 ha forest land re-diverted from seabird to NHAI. When Forest Department informed the excess use of land by NHAI, then immediately NHAI submitted a re-diversion proposal for 2.469 ha on 27.04.2018. Then the nodal officer (FC) admitted the proposal and submitted to MoEF & CC, Government of India for diversion of forest land.

Here, there is no intentional violation on part of NHAI/Project seabird. The User Agency is pursuing the proposal since 27.04.2018.
