

2	With respect to Point No 4 of previous EDS on employment data it is seen that it shows 10 number of permanent employment and 15 number of man days to be generated which does not seem to be correct.	Correct Employment details have been filled at section E in Form A, part I.
3	With respect to Point No 5 & 6 of previous EDS related to FRA certificate it is seen that proceedings of VLC meeting for Tolab village is still not uploaded. Besides, FRA certificate in original and its annexure (attested/ in original) is required in hard copy.	Relevant information attached with FRA at section K in is Form A, Part I.
4	With respect to point No 7 of previous EDS, hard copy of CA is still not received.	Hard copy of Relevant document has been sent by post.
5	With respect to point No 8 of previous EDS on submission of original copy of Part III, IV & V it is seen that hard copies are still not received.	Original hard copy of the proposal have been sent by post.
6	In response to EDS Point No. 4, it is observed that the patches of CA are not marked on Survey of India toposheet map uploaded online in Part -II.	Correct SOI, toposheet, maps have been uploaded in form A, Part II.
7	Upon DSS analysis, it is found that CA area marked as 8.715 ha comes to 4.829 ha instead. Therefore, as per the software conclusions, the area is far shorter than the required area. It is, therefore, requested to submit correct KML file of CA having area of 8.715 ha.	Relevant document have been uploaded in Form A, part I.
