I submit that the additional details called for in the reference 12th cited, are submitted. As per reference 1st cited, the user agency has submitted proposal for relaying and periodical maintenance of GST road to Vadagal Road at KM 1/314 – 2/0 in Chengalpattu District of road for 0.686 Ha

in Paranur RF. it was mentioned in proposal that this road was construction before 1985 and maintained by Rural Development Department. The last renewal was carried out prior to 2010 and the road is heavily damaged for the past 11 years in forest portion the stretch found with lot of surfaces worn outs, ruts, potholes which is discomfort to the road users and fast moving vehicles.

As per reference 2nd cited, Forest Range Officer, Chengalpattu has reported that the road passing through between forest boundary stone No.8 and 9 of Paranur Reserved Forest and there is right of way No.4 in the Paranur Reserved Forest notification along this road of 12 feet with. The existing road width is 7meter.

In reference 3rd cited, District Forest Officer, Chengalpattu Division a letter was addressed to Divisional Engineer, Highways Department, Rural Roads, Chengalpattu requested to clarify the following.

- 1. Whether any permission from the Forest Department for black topping and subsequent maintenance was obtained?
- 2. If yes, kindly provide the order copy or relevant document other of the same.

As per reference 4^h cited, Divisional Engineer, Highways Department, Rural Roads, Chengalpattu reported that no documents are available in the office regarding for obtaining permission from forest department for the work carried out earlier.

As per reference 5th cited, District Forest Officer, Chengalpattu Division a letter was addressed to Deputy Director and Project Director, District Rural Development Agency, Chengalpattu requested to clarify the detail information of the person responsible for the violation and awaiting response from the District Rural Development Agency for same.

This Office reference 9th cited, additional report called for by the Government a letter was addressed to Divisional Engineer, Highways Department, Rural Roads, Chengalpattu requested following details.

- As mentioned in your proposal, the last renewal was carried out for this
 road before 2010, whether any permission from the Forest Department
 for black topping and subsequent maintenance was obtained. If yes,
 kindly provide the copy of the same.
- 2. If there are no permission was obtained then it amounts to be violation of provision of Forest Conservation Act, 1980.

In this case, please provide the details of person responsible for violation, along with the authority. Also provide details of duration during which construction and maintenance work was carried out.

As per reference 10th cited, Divisional Engineer, Highways Department, Rural Roads, Chengalpattu based on District Collector, Chengalpattu letter reference no.4946/2023/A12, dt.07.12.2023 reported that the Chengalpattu District was formed during march 2020 bifurcated from combined Kancheepuram District. Hence, the particulars of Road work executed are not available in Chengalpattu District and not traceable from Kancheepuram District.

As per Government letter reference 6th cited it was instructed to take action in this regard, I submit that, as mentioned above the particulars of the work executed are not available is Chengalpattu or Kancheepuram District. Hence, it is not possible determine person responsible for violation, against whom action to be initiated as per Government of India Ministry of Environment, Forest and Climate Change (Forest Conservation Division) No. 11/113/2022-FC-Part (1), dt.15.05.2023.

Based on the above facts, I submit detailed replay as follows:

(A). The user agency and official(s) responsible for violation of Forest (Conservation) Act, 1980.

As per the proposal the road was constructed before 1985 by District Rural Development Agency. However, as per the 4th and 10^h cited, particular of road work executed are not available. Thus, it is not possible to determine official responsible for violation.

(B). Year in which the existing road was built/constructed.

As per the proposal the road was constructed before 1985.

As per the reference 4th and 10th cited, particular of road work executed are not available. Hence, it is not possible to determine exact year in which the existing road was built/constructed.

(C). Forest Department Officials who are all responsible for not preventing of such violation.

As per the proposal the road was constructed before 1985. As per the reference 4th and 12th cited, particular if road work executed are not available. Hence, it is not possible to determine exact year in which the existing road was

built/constructed and due to unavailability of documents cannot be found out the departmental officer who are responsible of such violation.

(D).Action Taken by the State Government so far on officials responsible for violation may be submitted.

As a long time has been lapsed since construction of road and due to unavailability of proper documents, it is not possible to determine officials responsible for violation. Hence, no action can be taken in this regards.
