So following submission is being made along with Conservation and Management Plan for this project for approval from your office.

1	DCF, West Nashik has mentioned in his Part-II that there is presence of White Rumped Vulture, Long Billed Vulture and Leopard which are Schedule-I species. Specific comments from PCCF (Wildlife) in this regard needs to be submitted. Management Plan for Wildlife Habitat received from Deputy Conservator of Forests West Nashik office letter No.842, dated 14/08/2023 (Ref.no.5) This office agrees to the Management Plan for Wildlife Habitat submitted by the Deputy Conservator of Forests, West Nashik and also follow mitigation measure – To creat a gentle slope of 1:5 in the side wall 5 m wide of canal for driving the fallen heavy wild animal in the canal to that point. So that the animal can climb the wall on his own. The same is being submitted to your office for further necessary action.
