



1. Uploading of information in Para A -2 (xiii) and Para B -1 (i) of Online Part One could not be uploaded due to technical problems in the required online fields. The required information is being uploaded at Form -B, Part One as Additional Information. Details and signed hard copies of reply to EDS Point No. 9 has been submitted to the Regional Office and Nodal Office UK vide Nodal Office Dehradun letter No. 4237/FP/UK/Others/177556/2016 Dehradun dated 22 March 2021 and lessee letter No. 46197/A/Pers-01 dated 28 Feb 2021.
2. The required details to Point No. 9 are as under:
 - i). **A-2. Details of User Agency**
(xiii). **Details of Proposals seeking prior approval of Central Government under the Act for diversion of forest land submitted by the User Agency in the past:**
 - a). The Single Patch of 0.0608 hecter was originally leased for constructing a house in 1924. Subsequent renewals were done in 1938 – 1945 – 1953 – 1982.
 - b). Lessee applied for renewal in 1981,1999,2000,2002,2005,2007,2009 and the present lessee uploaded the proposal in 2015. Delay was due to inaction by UP Govt. till proposal transferred to UK Govt. in 2001 and further delayed till formation of UK State Forest Policies. Uploaded on 30.12.2015. Approved by UK State Govt. on 28/03/2016. Presently prior approval of Central Government under the Act for lease renewal of said Plot is hereby applied for by the User Agency.
 - ii). **B -1 Details of proposal seeking prior approval of Central Government under the Act for diversion of forest land for the Project already submitted in the past.**
(1). **Whether any proposal seeking prior approval of Central Government under the Act for diversion of forest land required for the project has been submitted in the past?** - Yes. The proposal for renewal of lease was submitted to UP Govt. in 1981. Due to delay it was transferred to UK Govt. in the year 2001. Lessee again applied in 1981,1999,2000,2002,2005,2007,2009 till new UK State Forest Policies were formalised. The UK State Govt. approved the proposal on 28/03/2016.
Required documents have since then been submitted for final approval and No Objection by Regional Office Dehradun. Signed hard copies submitted to Nodal Office UK and Regional Office Dehradun vide Nodal Office Dehradun letter No. 4237/FP/UK/Others/177556/2016 Dehradun dated 22 March 2021 and lessee letter No. 46197/A/Pers-01 dated 28 Feb 2021. Approval of Central Government is hereby awaited and uploaded.


