



It is to clarify that other options were also explored but there was no
alternate route which was technically feasible other than the proposed 1300 mtr of the
wildlife area which was coming in the alignment of the road which was unavoidable involved
0.78 ha of land which was the minimum possible wild life land that need to be diverted for
connecting the approved habitation.

Recommendation

The proposal is recommend subject to the following conditions strictly by the user agency.

1. All the rules and regulations as per the Wildlife (Protection) Act, 1972 and directions and orders from the Hon'ble Supreme Court in this regard may be adhered strictly.
2. No realignment should be done.
3. All construction materials and other may be brought outside the conservation reserve.
4. The User Agency should abide by any other conditions that may be prescribed by the Chief Wildlife Warden, J&K Government.
5. The felling of the trees should be done as per the Forest (Conservation) Act 1980 and guidelines issued by Ministry of the Environment, Forest and Climate change vide F. No. 11-63/2012-FC dated 29 Sep 2016.
6. The muck disposal should be outside the protected area.
7. Proper retaining and breast wall should be constructed to avoid the landslides in the area simultaneously with excavation work.
8. Change of drainage should be properly managed to reduce further damage to the area.
9. Proper speed control beakers should be constructed to avoid the speedy/ rash driving inside the conservation reserve.
