Furnish the location of the pits and status of reclamation of forest land exhausted for minerals regarding the existing lease of Sri G.Maddilety Reddy, Banaganapalli	<p>The DFO, Kurnool has submitted that the location of the pits of the existing quarry lease under operation by M/s GMR Stone Crushers, Prop.Sri G.Maddilety Reddy, Banaganapalli in Compt.No.313 of G.A.Bad South RF duly signed by the DFO,Kurnool is enclosed in (3) sets.</p> <p>Further the DFO, Kurnool has submitted that the user agency has submitted that an area of 2.662 Ha. has been granted Quarry lease in Compt.No.313, G.A.Bad South RF, Dhone Range, Kurnool Division in favour of M/s GMR Stone Crushers, Prop. Sri G.Maddilety Reddy, R/o Banaganapalli vide G.O.Ms.No.84, EFS&T (For.I) Dept, Dt.31.10.2012 for mining of quarry Road metal from 03.10.2012 to 02.10.2022.</p>

Further it is also submitted by the DFO that the mining operations were carried out in 1.687 Ha. area only as against 2.662 Ha. granted for lease. The remaining balance area 0.873 Ha. is not touched so far. And area of 0.102 Ha. is being used for Road for transport of mined material.

With regards to reclamation, the user agency has submitted that the mining operations in the above area are undergoing as sufficient potential and good quality material is available. Hence proposed to mined the minerals till the mining period is over by 02.10.2022. Further, the user agency has submitted that the reclamation will be attended with overburden material at the site as soon as once the lease period is over and handed over to the Forest Department.

The condition wise compliance report on stage-II approval with regards to the existing mining lease granted for 2.662 Ha. of forest land in Compt.No.313, G.A.Bad South RF of Dhone Range of Kurnool Division for quarry of Road Metal in favour of M/s GMR Stone Crushers, Prop. Sri G.Maddilety Reddy, R/o Banaganapalli has already been submitted in CF, Kurnool Rc.No.133/2010-TO, Dt.19.07.2022. However a copy of the same is submitted herewith.




