With reference to the above subject, Govt of India vide reference (1) has raised EDS Query seeking clarification and information from User Agency. In this connection the Deputy Conservator of Forests, Kundapura Division, Kundapura has submitted a report vide reference (3) to this office.

As per the report of Deputy Conservator of Forests, Kundapura, the area identified for the construction of 11 KVHT express power line (AB covered conductor cable) from Hebri Mussa to Waranga is 1.2411ha and it is passing within the Mudradi-Hebri right of way (44 yards wide) area in Jarwathu reserve forest. (Copy enclosed) Hence, recommended to **close the Proposal No: FP/KA/TRANS /43222/2019** which was submitted on Parivesh Portal as per the request of Executive Engineer (V) (O&M) Division, Mescom, Karkala.

Hence, it is requested to kindly move the matter with Government to close this case under Forest (Conservation) Act 1980. This is for your information and further needful action.
