Kindly refer above quoted subject matter and communication. In this connection, it is submitted that the subject proposal, processed under the provisions of FCA, 1980 and duly completed as per prescribed check list for DFOs stands submitted to your office vide this office No. DFO/Kmj/2813-17/L Dated:-13-02-2021. However the necessary pending documents to be submitted by the DFO i.e. Check list duly signed by the DFO, suitability certificate from the DFO regarding area proposed under CA have been uploaded and with regard to comprehensive scheme for compensatory afforestation the matter has been taken-up with the higher authorities for necessary approval.
