Subject: - **Diversion of 4.7 ha. of forest land in favour of HPPWD for the construction of Kiari to Khinna road Kms. 0/0 to 7/820, within the jurisdiction of Solan Forest Division Distt. Solan, HP.**

Kindly refer to your office memo No. Ft.48-3645/2017 (FCA) dated 27.04.2024 on the subject cited above.

In this context, it is submitted that the observations as raised vide your office memo referred to above have been attended by DFO Solan/User Agency is as under:-

S. No.	Observation	Reply
1.	Documentary Proof in respect of C/o Road before 1980 Be Provided	User Agency has submitted the undertaking of concerned Lamardar and Ex-Pradhan which has been verified by Tehsildar Kandaghat and Block Development Officer Kandaghat, Distt. Solan. The both statements has been uploaded in additional information details.
2.	WLMP is Not Correct. Correct plan showing all technical details along with financial implications be uploaded.	The WLMP duly signed by DFO Solan and Executive Engineer HPPWD Solan has been uploaded on the portal in additional information. DFO Solan has submitted that the WLMP has been prepared amounting to Rs. 15.60 Lacs only which is 2% of the project DPR Cost.
3.	Point No. 3 not attended as EROW/PROW are required to be marked in proposed KML File.	The existing and proposed Right of Way have been marked by the UA in the Proposed KML File.
4.	Point No. 04 not attended. Length & Width of Broken Area and un-Broken Area is required to be uploaded.	The detailed length and width of broken & un-broken Area at every 15.00 meters interval duly signed by the Executive Engineer HPPWD Solan has been uploaded in the additional information details.
5.	As per the KML File trees are visible on proposed dumping site,hence, clarification be provided. Further, as per Check List 07, 0.0252 hectare of non-forest land is involved in the present proposal but no such detail has been mentioned in Part-1, layout plan and KML File of the proposed project. The revised KML file showing the non-forest/forest EROW/PROW in polygon shape be uploaded and non-required/contradictory documents be deleted from the portal accordingly.	The site was jointly inspected by the Range Forest officer Chail & S.D.O. HPPWD Kandaghat, Distt. Solan wherein it was observed that there are no trees standing at the proposed dumping site (copy uploaded). DFO Solan has further intimated that 0.0252 Ha land had been wrongly mentioned in checklist 07 as non-forest land by the HPPWD. The said land is a Forest land (Jamabandi enclosed) area, which has already been considered in the total 4.7 hectares of Forest Land and the same has already been uploaded in part-1. Fresh Checklist in this regard titled as Checklist 08 has now been appended and corrected Checklist 07 corrected and mentioned as NIL which has also been uploaded.
