## Section 3 A- Penalty for contravention of the provisions of the Act.

### Section 3 B- Offences by the Authorities and Government Departments.

The Construction work of four laning of Pune-Solapur section NH-9 from Km. 144.00 to Km 249.00 done in RF Gut no 203 of village Pakhani Tal North Solapur and Identified Forest gut no 6 of village Hivare and gut no 8, 9 of village Chikhali Tal Mohol Dist Solapur Maharashtra State. Work completed on forest land between 17 August 2012 to 15 December 2012 by PIU, NHAI-Solapur as per violation report submitted by Project Director, NHAI, Solapur.

As per Project Director, NHAI, Solapur said work has been started on forest area as per order no मशा/कार्या-3/3क/कावि/237/एसआर 44/2012 dt. 20/04/2012 by then Collector- Solapur and award no उभूसंक्र.5/एसआर/26/2008, dt. 03/03/2011 by then Competent Authority and Deputy Collector (Land Acquisition) no. 5. This office vide letter no B/D-13/Survey/FCA/2867, dt. 29/01/2011 has already informed to Collector- Solapur that above gut number area is forest area.

As per above fact that Project Director, NHAI, Solapur was aware the proposed diverted 3.36 ha forest area but they have completed road construction. Hence, prima facie in this matter 1) Shri. Gokul B. Maware, then Collector- Solapur 2) Shri. M. B. Borkar, then Competent Authori and Deputy Collector (Land Acquisition) no.5 as 3) Shri. B. B. Ikhe, then Project Director, NHAI, Solapur and Shri. M. S. Bokfode, then Range Forest Officer, Mohol are responsible for violation (as per available record). This is for information and necessary action.
