Though the project approval letter has been uploaded and it has been found that estimated cost of the project is 29.54 lakh but as per the detail mentioned in the column A-I (vii) of Part-I total 150 lakh has been mentioned which need to be rectified/clarified.	In this context, the user agency has submitted that necessary correction has been made in online Part I in web portal.
2.	CA has been proposed on UPF Hanoh but it has still not been mentioned whether the said area is notified as forest under IFA, 1927 or it is declared as protected forest as per 1952 notification of Gol.	In this context, It is submitted that UPF Hanoh is Un-Demarcated Protected Forest and is covered in the working plan of Hamirpur Forest Division and compartment History file of the same is uploaded as additional information in online Part-II.

The reply is not acceptable Gol has asked for furnishing the Action Taken Report against the violators as per Para 1.21 (i) and/ or (ii) of FCA Guidelines may submitted/ uploaded in the portal and detail in this regard be mentioned against the column No. 11 of Part-II accordingly	It is submitted that Proposed road is constructed by HPPWD and is also listed in the list of roads constructed in violation in CWP No. 5600 of 2012 dated 05.09.2013 titled as Sh Manoj Kumar Vs Charan Vs UOI and others” linked the COPC No. 56 of in pursuance of Govt. HP Notification No. FFE-B(3)-31/2012 dated 21.10.2013 has given one time relaxation for all HPPWD roads where violation has been committed on Serial No 10 as “Construction of Link Road to Village Swahal”
4.	The CA detail for the should be uploaded in the appropriate column of part-II alongwith KML file of the portion where the trees are to be planted	The CA scheme alongwith all documents have been uploaded against Sr.13 of Part-II.
